**RESOLUTION TO APPROVE THE BID OF MJ CONSTRUCTION, INC. FOR LEAD SERVICE LINE REPLACEMENTS AT VARIOUS LOCATIONS AROUND THE CITY OF WEST ALLIS IN THE AMOUNT OF \$1,383,750**

**WHEREAS**, the Board of Public Works duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in certain areas as described below, and the bids received were reasonable; and,

**WHEREAS**, the Board of Public Works recommends and deems it to be in the best interests of the City of West Allis that the bid of MJ Construction, Inc. for 2026 Project No. 11 be accepted.

**NOW THEREFORE**, be it resolved by the Common Council of the City of West Allis that the bid of MJ Construction, Inc. for 2026 Project No. 11 for private lead water service line replacements at:

- W. Walker St. from S. 60th St. to S. 59th St.
- W. Mineral St. from S. 63rd St. to S. 62nd St.
- W. Orchard St. from S. 62nd St. to S. 60th St.
- Area bounded by north City limits to Union Pacific Railroad Tracks and S. 70th St. to S. 76th St.
- S. 77th St. from W. Pierce St. to W. Walker St.
- S. 83rd St. from W. Becher St. to W. Grant St.
- S. 86th St. from W. Washington St. to W. Greenfield Ave.
- S. 89th St. from W. Greenfield Ave. to W. Orchard St.
- S. 91st St. from dead end north of W. Rogers St. to W. Rogers St.

for the sum of \$1,383,750 be accepted.

**BE IT FURTHER RESOLVED** that the proper City officers are authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

**BE IT FURTHER RESOLVED** that said improvements be installed with funding by Safe Drinking Water Load Program funds and Capital Projects cash reserves (future reimbursement from special assessments).
