**RESOLUTION APPROVING A PROPOSAL BY RIVER RUN FOR CYBER  
SECURITY NETWORK SERVICES**

**WHEREAS**, the City of West Allis provides certain purchasing and fiscal agent services for North Central High Intensity Drug Trafficking Area (North Central HIDTA), as provided in a Memorandum of Understanding approved on October 1, 2024 (Resolution R-2024-0567); and,

**WHEREAS**, North Central HIDTA's server is in need of a critical network upgrade to immediately improve cyber security; and,

**WHEREAS**, on December 23, 2025, the Mayor declared an emergency, allowing for the immediate procurement of goods and services; and,

**WHEREAS**, North Central HIDTA sought proposals from three providers and chose River Run's proposal for the network rebuild project; and,

**WHEREAS**, the Mayor has directed the North Central HIDTA Department of Information Technology to facilitate this purchase.

**NOW THEREFORE, BE IT RESOLVED** by the Common Council of the City of West Allis that the proposal by River Run is approved.

**BE IT FURTHER RESOLVED** that the Finance Director or designee is authorized to execute this purchase on behalf of North Central HIDTA.

**BE IT FURTHER RESOLVED** that the equipment costs, including host server hardware and back-up workstation, totaling \$21,959.10 shall be charged to Account # 255-8101-521.51-09, Project # I25549.

**BE IT FURTHER RESOLVED** that the software licensing and service costs, including labor and professional services, totaling \$55,510.10 shall be charged to Account # 255-8101-521.30-04, Project # I25549.


