**RESOLUTION TO APPROVE A PARTNERSHIP WITH MILWAUKEE SPORTS AND  
SOCIAL FOR USE OF SPACE AT LIBERTY HEIGHTS PARK FOR VARIOUS SPORT  
LEAGUES**

**WHEREAS**, Milwaukee Sports and Social has submitted a formal proposal to utilize the facilities at Liberty Heights Park for the organization and operation of adult recreational sports leagues, including sand volleyball, pickleball, tennis, softball, and kickball; and

**WHEREAS**, the City of West Allis recognizes the value of providing high-quality recreational and social opportunities that encourage community engagement, promote an active lifestyle, and enhance the quality of life for residents and visitors; and

**WHEREAS**, a partnership with Milwaukee Sports and Social will help attract new visitors to the City, increase foot traffic to local businesses, and generate economic benefits through post-game partnerships with West Allis restaurants and bars; and

**WHEREAS**, Milwaukee Sports and Social has a demonstrated history of successfully managing organized recreational leagues in neighboring communities while ensuring the responsible use and maintenance of public facilities;

**NOW THEREFORE**, by the Common Council of the City of West Allis, Wisconsin, that City staff is directed to negotiate and draft a formal agreement with Milwaukee Sports and Social, ensuring the terms align with the submitted proposal and uphold the best interests of the City; and

BE IT FURTHER RESOLVED that the Mayor is hereby authorized to execute the agreement on behalf of the City.
