

**CITY OF WEST ALLIS
RESOLUTION R-2025-4601**

**RESOLUTION APPROVING A RATE CHANGE IN THE 2026 SANITARY SEWER
USAGE CHARGE - CITY PORTION**

WHEREAS, Section 1.07(4)(e) authorizes the Common Council to revise sanitary sewer user charges, as necessary, to ensure that the system generates adequate revenues to pay the cost of operation and maintenance, including replacement of the Sanitary Sewer Collection System; and,

WHEREAS, the sanitary sewer rates were last changed January 1, 2023, when the rate increased \$0.20 to the current rate of \$2.15 per CCF; and,

WHEREAS, the 2026 proposed budget requires an increase in the sanitary sewer user charge to pay the cost of sanitary sewer operations, maintenance, and capital.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that there be a 2026 increase in the rates for the sanitary sewer user charge - City portion, and is hereby changed to \$2.40 per CCF of water used per quarter from \$2.15 per CCF of water used per quarter (an increase of \$0.25 per CCF), with the minimum quarterly charge increased to \$24.00 per quarter from \$21.50 per quarter (an increase of \$2.50 per quarter) effective January 1, 2026.

BE IT FURTHER RESOLVED that Utility Billing Staff be and is hereby directed to notify each user of the Sanitary Sewer Collection System of the aforesaid rate increase as provided in Section 1.07(4)(f) of the Revised Municipal Code.
