RESOLUTION R-2025-3000**

**RESOLUTION AUTHORIZING ENTERING AN AGREEMENT WITH WISDOT TO
MITIGATE TRAFFIC IMPACTS ON VARIOUS CITY STREETS DURING THE I-94
EAST WEST FREEWAY PROJECT**

WHEREAS, The Wisconsin Department of Transportation (WisDOT) is reconstructing the I-94 East West Freeway from S. 70th St to 16th St. (PROJECT) starting in fall 2025.

WHEREAS, I-94 freeway travel lanes will be reduced during construction which may cause traffic congestion on local alternative route streets within two miles of the interstate roadways.

WHEREAS, WisDOT acknowledges and agrees that adaptive signals and other various traffic calming measures will help ensure the safety, accessibility and mobility for the traveling public in the PROJECT area.

WHEREAS, WisDOT will reimburse up to \$730,320 to the City of West Allis (CITY) to purchase and install equipment to mitigate traffic impacts of the PROJECT as outlined in the attached Agreement and as follows:

1. Rectangular Rapid Flashing Beacon at 75th & Greenfield Ave
2. “No Traffic” signal equipment at 12 city signalized intersections to provide adaptive signal control and detection at key locations along the Greenfield Ave (WIS 59) corridor from S. 81st St. to S. 60th St. This new technology can optimize signal operation in real time using artificial intelligence.
3. Traffic calming measures such as temporary speed tables or other traffic control devices to be installed on residential streets experiencing increase traffic during construction

WHEREAS, the CITY will own, maintain, and operate the traffic mitigation equipment and be reimbursed by WisDOT for actual costs incurred and attributable to equipment and work performed as described in the AGREEMENT.

NOW THEREFORE, THEREFORE, BE IT RESOLVED By the Common Council of the City of West Allis that City staff are hereby authorized and directed to enter into the AGREEMENT with WisDOT for this project.

BE IT FURTHER RESOLVED That a copy of this resolution, together with the executed AGREEMENT, be submitted to WisDOT;

BE IT FURTHER RESOLVED That City staff are authorized to take whatever further action is required to initiate and fulfill this AGREEMENT.
