**RESOLUTION TO APPROVE BID OF LALONDE CONTRACTORS, INC. FOR
STREET CONSTRUCTION AT S. 75TH ST. FROM W. BELOIT RD. TO W.
ARTHUR AVE., S. 90TH ST. FROM W. GREENFIELD AVE. TO W. SCHLINGER
AVE., W. WASHINGTON ST. FROM S. 89TH ST. TO S. 90TH ST., AND S. 94TH ST.
FROM W. ORCHARD ST. TO DEAD END IN THE CITY OF WEST ALLIS IN THE
AMOUNT OF \$1,055,203.15**

WHEREAS, the Board of Public Works duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements at the locations described below; and

WHEREAS, the bids received were reasonable; and

WHEREAS, it is in the best interests of the City of West Allis that the bid of LaLonde Contractors, Inc. for 2026 Project No. 9 be accepted.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the bid of LaLonde Contractors, Inc. for 2026 Project No. 9 for the installation of asphaltic street resurfacing, concrete curb and gutter, concrete pavement patching, concrete sidewalk, pavement milling, lead service line replacements, pavement marking, building services, and utility adjustments at the following locations for the sum of \$1,055,203.15 is accepted:

- South 75th Street from W. Beloit Rd. to W. Arthur Ave.
- S. 90th St. from W. Greenfield Ave. to W. Schlinger Ave.
- W. Washington St. from S. 89th St. to S. 90th St.
- S. 94th St. from W. Orchard St. to Dead End

BE IT FURTHER RESOLVED that the proper City officers are authorized and directed to enter into contractual relations with LaLonde Contractors, Inc. for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected.

BE IT FURTHER RESOLVED that said improvements be installed with funding by street and utility bond funds, street and utility sewer cash, and Capital Projects cash reserves (future reimbursement from special assessments).

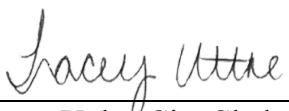

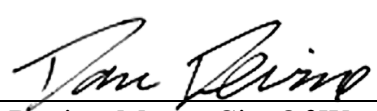
