The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of March 2011.

Incident reports:

Case 11-002024, 03/04/11 at 0143hrs. GR's National Pub, 6827 W National Ave.

On the above date and time the bartender at GR's National Pub called to report a fight in the bar. Two brothers were intoxicated and were the main instigators in a fight in the tavern. Both were arrested and cited for Disorderly Conduct.

Case 11-003093, 03/06/11 at 0159hrs. Crazy Horse Gentlemen's Club, 9442 W National Ave.

On the above date and time officers responded to a call from two parties stating that they had been assaulted after being escorted out of the Crazy Horse Gentlemen's Club. The two parties had gone to the club with three other friends. After they were escorted out three unknown parties attacked them. Two witnesses stated that the club bouncers were not involved but did not try to stop the fight and that the three unknown parties walked away from the skirmish with them. There is video in the parking lot but the IT person for Crazy Horse stated that his equipment was malfunctioning. No arrests at this time. The two parties were transported to the Aurora West Allis Medical Center to check out their injuries.

Case 11-002151, 03/08/11 at 0100hrs. Magoo's, 8911 W National Ave.

On the above date and time officers arrested a male for 6th offense Operating While Intoxicated. While talking to the party he claims he was involved in a fight at Magoo's. Party was transported to Aurora West Allis Medical Center for a blood draw and was also checked out for injuries, which turned out to be a broken collarbone.

Officers checked at Magoo's where it was verified that the party was involved in a fight, which apparently started over a female. No suspects at this time.

Case 11-002174, 03/09/11 at 0053hrs. 57 Bar, 5632 W. Burnham St.

On the above date and time Officer Sitter was flagged down outside the 57 Bar regarding a fight in the parking lot. The investigation revealed that a female party was very intoxicated and caused a disturbance in the bar. After being escorted out of the bar she assaulted two patrons in the parking lot. This party was subsequently arrested for disorderly conduct and resisting an officer.

Call 11-010191, 03/13/11 at 0303hrs. Mugshotz Tavern, 1902 S 68 St.

On the above date and time Officer Hurley made contact with a male party who fell on private property outside Mugshotz tavern, located at 1902 S. 68th St. This subject said he had too much to drink and denied medical treatment on scene. This party said he was drinking at Mugshotz. Officer Hurley transported this party to his residence without incident.

Case 11-002429, 03/18/11 at 0049hrs. Callahan's Parkway Pub, 11505 W. National Ave.

On the above date and time, the bartender at Callahan's Parkway Pub called our department regarding a disorderly male party who spit on the bar and knocked over several bar stools. Officers located this party across the street from the tavern. This party was cited for disorderly conduct — he was transported to the station and held until sober.

Case 11-002455, 03/19/11 at 0136hrs. Double Barrel Tavern, 1100 S. 60th St.

On the above date and time officers were called to investigate an intoxicated male down in front of Double Barrel. The male was extremely intoxicated and eventually fought with officers and firefighter personnel. It was learned that the bartender cut the male off and he became agitated. He assaulted the bartender and was escorted outside. Once outside he attempted to punch a patron and fell back striking his head. The party was arrested and charged at the Milwaukee County District Attorney's Office with Disorderly Conduct, Resisting and Battery to a Law Enforcement Officer.

Call 11-0121152, 03/27/11 at 0018hrs. Hero's Tavern, 9105 W Lincoln Ave.

On the above date and time officers responded to a parking complaint at Big Ebe's Pizza 9125 W Lincoln Ave. The owner complained that a patron of Hero's parked his car in the Ebe's lot and proceeded to Hero's. The complainant told the party he couldn't park there but the party ignored him and went into a bar. Parking ticket issued.

Tobacco and Alcohol Compliance checks;

On March 25, 2011 Officer Ketterhagen performed an Alcohol Compliance Check. 23 businesses were checked and all were in compliance.

Violation of Wisconsin Clean Air Act Smoking Ban;

There was one (5) reported violations for the month of March.

Case 11-002325, 03/07/11 at 0106hrs. Wild Bill's Saloon, 1454 S 92 St.

The bartender who was smoking was issued a citation along with the license holder. The bartender who stated she didn't know the law was caught in a lie as she had been warned at an earlier date about smoking in the bar.

Case 11-002216, 03/10/11 at 0055hrs. D & D Sports Bar, 1022 S 60 St.

One patron of D & D Sports Bar was issued a citation for smoking inside of the bar during a bar check. The bartender who was present was issued a warning. The offender stated that the owner and bartender allow patrons to smoke in the bar.

Case 11-002243, 03/10/11 at 2222hrs. Czars, 6901 W Beloit Rd.

Two parties who were smoking inside of Czars during a bar check were issued a citation violating the Wis. Clean Air Act. The license holder was issued a warning.

Case 11-002388, 03/16/11 at 2121hrs. Smokin' Joes, 6139 W Beloit Rd.

One patron of Smokin' Joes was issued a citation for smoking inside of the bar during a bar check. The owner was mailed a warning.

Case 11-002525, 03/22/11 at 0132hrs. Network Tavern, 9541 W Cleveland Ave.

A Patron who was smoking was issued a citation along with the license holder who was present.
