An Ordinance to amend Sections 7.121(1)(b) and 7.122(1)(b) of the City of West Allis Revised Municipal Code regarding dog and cat license late fee amnesty period.

The Common Council of the City of West Allis do ordain as follows:

PART I. Section 7.121(1)(b) shall be amended by adding the following:

“The provisions of this subsection notwithstanding, whenever the Milwaukee Area Domestic Animal Control Commission (MADACC) shall declare an amnesty period for late dog license fee charges, the fee, if any, set by MADACC shall apply for the period of the amnesty.”

PART II. Section 7.122(1)(b) shall be amended by adding the following:

“The provisions of this subsection notwithstanding, whenever the Milwaukee Area Domestic Animal Control Commission (MADACC) shall declare an amnesty period for late cat license fee charges, the fee, if any, set by MADACC shall apply for the period of the amnesty.”

PART III. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART IV. This ordinance shall take effect and be in full force from and after its passage and publication.

## **Animal Licensing is required for all dogs and cats over 5-months-old in West Allis!**

### **Why license?**

1. Licensing is one important part of responsible animal ownership! Licensed pets have been vaccinated for rabies which protects residents and other animals.
2. Pets that are found wearing a current license tag are put on the FAST TRACK HOME! If your pet is licensed we will already have your contact information and rabies information in our computer system which will expedite the return home of your companion.
3. Pets that are found wearing a current license tag are also eligible for an annual "Free Ride Home" by Milwaukee Area Domestic Control Commission (MADACC) Animal Control Officers! This saves your animal the stress of coming into the facility and you from the expenses associated with reclaiming an animal. Please note that we have to be able to reach you when we pick up the animal to take advantage of this program! Current contact info is always important!
4. Reclaimed cats and pit bull type dogs are eligible for a FREE spay or neuter surgery!

**Licenses must be purchased each year in December for the next calendar year.** There is a built in grace period before late fees kick in. License fees are as follows:

Altered (spayed or neutered) dog or cat prior to April 1	\$ 12.00
Intact or Unaltered dog or cat prior to April 1	\$ 24.00
Altered (spayed or neutered) dog or cat starting April 1	\$ 18.00
Intact or Unaltered dog or cat starting April 1	\$ 36.00
Puppies or Kittens – special fees for new family members	
Altered and are 5-months-old AFTER July 1	\$ 6.00
Intact and are 5-months-old AFTER July 1	\$ 12.00

If you live in West Allis and your animal ends up at MADACC, you will pay:

Ordinance Fee	\$ 25.00
Impound Fee	\$ 30.00 (for an unlicensed animal, \$20 for licensed animal)
Boarding Fee	\$ 15.00 (and each day that goes up \$15)
License Fee	\$ 12.00 (\$24.00 for intact animal – late fees even higher!)
Rabies Vaccine Fee	\$ 25.00
Total	\$107.00 (and could go higher depending on above variables)

Or simply pay \$12 or \$24 for a license and get a FREE RIDE HOME!


