RESOLUTION R-2026-5589**

**RESOLUTION APPROVING A 3-YEAR EXTENSION OF THE CITY'S
CONTRACT WITH OPENGOV INC. FOR LICENSING, PERMITTING, AND
SERVICE DELIVERY SOFTWARE IN THE AMOUNT OF \$239,782.26**

WHEREAS, Resolution R-2021-0584 (adopted September 21, 2021) approved a 5-year contract with OpenGov for licensing, permitting, and service delivery software; and

WHEREAS, this software has improved customer service delivery, automated and streamlined internal workflows, and improved productivity; and

WHEREAS, staff have worked with OpenGov to reduce costs and refine the City's software package; and

WHEREAS, the total cost is \$239,782.26, to be paid over a 3-year term according to the following schedule:

- Year 1 (Effective 01/01/27): \$76,060.96
- Year 2 (Effective 01/01/28): \$79,864.03
- Year 3 (Effective 01/01/29): \$83,857.27; and

WHEREAS, it is in the best interests of the City that the attached proposal is accepted.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the proposal dated August 11, 2026 from Open Gov Inc. (Q-19599) for a total cost of \$239,782.26 over 3 years is accepted.

BE IT FURTHER RESOLVED that the City Administrator is authorized to enter into a contract with OpenGov Inc., to make any non-substantive changes to the approved documents to effectuate their intent, and to prepare and deliver any other documents necessary to complete the approved transaction.

BE IT FURTHER RESOLVED that this purchase will be charged to Account Number 100-1501-517.32-01

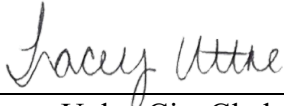

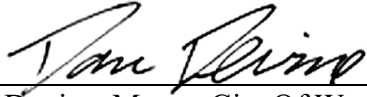
