

**CITY OF WEST ALLIS
RESOLUTION R-2023-0186**

RESOLUTION AUTHORIZING THE PURCHASE OF 25 BADGER BOOKS AND PRINTERS, 5 ADDITIONAL PRINTERS, 10 UPGRADED ROUTERS AND 3 POWER BRICKS FROM PDS, A CONVERGE COMPANY, FOR A TOTAL NET SUM OF \$53,867.10

WHEREAS, in 2020, the Mayor and Common Council of the City of West Allis adopted Resolution R-2020-0112, authorizing the purchase of 50 electronic poll book devices, known as Badger Books; and

WHEREAS, in 2022 the City of West Allis completed the redistricting process, creating the need to increase the number of polling places from 5 to 9; and

WHEREAS, increasing the number of polling places created the need for more Badger Books to serve more voters at each polling place; and

WHEREAS, since receiving the original order of 50 Badger Books, they have been used in 9 elections and hardware such as power bricks, printers and routers need replacing; and

WHEREAS, monies to purchase this equipment will be paid for with Fiscal Year 2022 carryover funding from the General Fund; and

WHEREAS, the Wisconsin Election Commission approved PDS as the vendor of choice for the sale of the Badger Books; and

NOW THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the proposal submitted by PDS for the purchase of 25 Badger Books and printers, 5 additional printers, 10 upgraded routers and 3 power bricks for a total net sum of \$53,867.10, be and is hereby accepted.

BE IT FURTHER RESOLVED the funds will be expended from account number 352-1502-514.70-03.

BE IT FURTHER RESOLVED, that the Purchasing Division be and is hereby authorized to purchase the aforesaid equipment.
