Mark Nisenbaum, 1652 S. 69 St., requested a neighborhood meeting to gather more information. He mentioned his concerns regarding safety, stoplights, additional police and parking. He indicated that the location is not right for a skate park.

Doris M. Kuhar, 1653 S. 68 St., commented on her concerns regarding increased criminal activity, parking, littering, traffic, taxes, alley use and lighting.

Tom Lipp, 2075 S. 58 St., and owner of the Dog House, opposed the proposal. He stated that the location is not suitable for children, and is concerned about the increased possibility of children attempting to enter his bar. He addressed parking concerns.

Joe Spolowicz, 1647 S. 57 St., favored a safe place for children to recreate. He commented on future leadership, supervision for the area, control over the location, and encourage children to remain in the community.

Joe Kucan, 1646 S. 57 St., favors the skate park. He opposes street skateboarding. He indicated that parking will not be an issue.

Judy Jenkins, 154 N. 80 St., said that children need a safe place to skate, and favors the proposal.

Jill Huennekens, 6210 W. Stevenson St., discussed curfews, and how the children will be inside and not create a hazard for cars. She commented that children will be picked up and dropped off, the cost of the sport, and how other communities have skate parks.

Ruth Kressl, 1637 S. 68 St., commented on her concerns regarding traffic and parking. She questioned the number of employees and the level of supervision. She indicated that the alley already has problems.

Tanner Kucan, 1646 S. 57 St., favors a skate park. He said that parking will be all right, and the children should remain in the community.

Jeff Dowhen, 8524 W. Harrison Ave., stated that parents drop off the children so parking will not be a problem. He mentioned that skate parks monitor themselves, and the supervision keeps the children out of trouble.

Kevin Nugent and Jon Holter, 6803 W. National Ave., owners of the business, indicated that parents are required to bring in their children, sign-up and sign releases. Also, they stated that crime will not increase. There is adult supervision, and the park would provide a good

outlet for the children. They said that skateboarding is a sport and should not be compared to a roller rink, plus the numbers are growing. They mentioned that children need a safe place to go.
