Upon deliberation and consideration of the complaint presented at the License and Health meeting held on December 2, 2014, the Committee finds:

**FINDINGS OF FACT:**

1. That PM Pub & Grub, Inc., by Dorene Monty, was properly served a copy of the summons and complaint;
2. That Dorene Monty admitted to the allegations that were stated in the complaint and, thus, the allegations in the complaint are considered to be true;
3. That the conduct of PM Pub & Grub, Inc. described in the complaint substantially relates to the licensed activity contrary to West Allis Revised Municipal Ordinance Section 1.08(9)(a);
4. That in particular, PM Pub & Grub, Inc.'s failure to pay its real estate taxes in full from 2011-2013 is contrary to West Allis Revised Municipal Ordinance Section 1.08(9)(a);

**CONCLUSION OF LAW:**

1. That the foregoing constitutes a sufficient basis to not renew the Class B Tavern License of PM Pub & Grub, Inc.

**RECOMMENDATION:**

1. Therefore, the License and Health Committee recommends to the Common Council of the City of West Allis that the Class B Tavern License of PM Pub & Grub, Inc. be revoked and not renewed if the real estate taxes owed by PM Pub & Grub, Inc., are not paid in full by cash or certified funds on or before January 6, 2015.
