An Ordinance to Establish Parking Restrictions on the East Side of the 1100 and 1200 Blocks of S. 71 St.

The Common Council of the City of West Allis do ordain as follows:

PART I. Pursuant to Section 10.10 of the Revised Municipal Code, the following parking restriction is established:

Street: S. 71 St.

Blocks: 1100 and 1200 Blocks

Side: East

Restriction: 1/2 Hour Parking 8:00 AM to 9:00 PM, Except Sunday

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect and be in force from and after its passage and publication.
