PUBLIC HEARING NOTICE

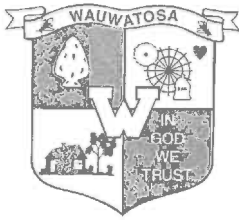

Adoption of the Mid-Town Tosa Master Plan and an amendment to the City of Wauwatosa 2008-2030 Comprehensive Plan to incorporate the Mid-Town Tosa Master Plan. The Mid-Town Tosa Master Plan includes a district spanning from Wauwatosa Avenue (N. 76th Street) to the Menomonee River and is home to over 10,000 residents, high-quality neighborhood schools, diverse restaurants, and a 12 block commercial trade district consisting of approximately 50 businesses.

ACTIVE TOSA: ORDINANCE ADOPTING THE PARK, TRAIL, OPEN-SPACE, AND RECREATIONAL FACILITIES MASTER PLAN AND AMENDING THE CITY OF WAUWATOSA 2008-2030 COMPREHENSIVE PLAN TO INCORPORATE THE PARK, TRAIL, OPEN-SPACE, AND RECREATIONAL FACILITIES MASTER PLAN

The Common Council of the City of Wauwatosa do ordain as follows:

- Part 1. Pursuant to sections 62.23(2) and (3) of Wisconsin Statutes, the City of Wauwatosa is authorized to prepare and adopt a comprehensive plan as defined in sections 66.1001(1)(a) and 66.1001(2) of Wisconsin Statutes. On December 16, 2008, the City of Wauwatosa adopted the City of Wauwatosa Comprehensive Plan 2008-2030 by ordinance and creating the section now numbered as 24.01.050 of the Wauwatosa Municipal Code. The City of Wauwatosa Comprehensive Plan is hereby amended to include the attached Park, Trail, Open-Space, and Recreational Facilities Master Plan.
- Part 2. This ordinance shall take effect and be in force from and after its passage and publication.
