The current Cable Franchise between the City of West Allis and Time Warner Cable expired on December 31, 2005. On the advice of the Assistant City Attorney a letter of agreement was signed by Paul Ziehler, representing the City, and John Herbert, President Milwaukee Division of Time Warner Cable. The letter extended the current Cable Franchise Agreement to March 31, 2006. The City is still negotiating with Time Warner Cable and both parties have agreed to a new extension date of June 30, 2006.

Mayor Bell and Alderperson Kopplin, Chair of the License and Health Committee, have also been apprised of the agreed upon extension. The City continues to negotiate with Time Warner to resolve the pending issue.
