# RESOLUTION TO ACCEPT THE SINGLE SOURCE PROPOSAL FROM CLEAR CHANNEL FOR OPIOID OVERDOSE PREVENTION BILLBOARDS.

**WHEREAS**, the City of West Allis has received opioid settlement payments as part of the National Opioid Settlement; and

**WHEREAS**, the Health Department has been assigned responsibility to administer and expend the City's Opioid Settlement funds; and,

**WHEREAS**, there is a need and opportunity to increase awareness of opioid-related overdoses, reduce the stigma associated with substance use disorders, and promote the important role that nalaxone plays in combating opioid-related deaths; and

**WHEREAS,** Clear Channel was selected as a single source bid for placement of educational billboards in the City based on their availability of billboards in the desired coverage area; and

**WHEREAS**, this initiative qualifies as an allowable use of opioid settlement funds; and

**WHEREAS**, the Finance Department maintains a segregated Opioid Settlement Fund to account for settlement payments received and corresponding expenditures to facilitate required compliance reporting; and

**WHEREAS**, the 2024 adopted budget included an appropriation for the Opioid Settlement Fund totaling \$255,322, but not specifically for this project;

**NOW THEREFORE,** NOW THEREFORE, BE IT RESOLVED that the Common Council of the City of West Allis:

- 1. Authorizes the Health Department to accept the proposal from Clear Channel to spend up to \$32,680.00 on opioid awareness billboards; and
- 2. Approves a budget transfer within the Opioid Settlement Fund from the Professional Services account to the Advertising Account to properly account for this expense (Acct: 241-8690-542-5403, Project H99102), and
- 3. Authorizes the Health Commissioner to take all other actions deemed necessary to complete this project.
