Michael J. Czaplewski, being duly sworn, on oath deposes and states as a complaint against Dilneet Corporation as follows: 1.

- That the complainant is a resident of the City of West Allis, is the duly elected Alderperson for the First Aldermanic District in the City of West Allis, is the chair of the License and Health Committee, and makes this complaint at the direction of the License and Health Committee of the West Allis Common Council.
- That the information contained in this complaint comes from the complainant's 2. review of official records maintained by the City of West Allis, which records complainant believes to be reliable and accurate.
- That Dilneet Corporation is the holder of a "Class A" Beer and "Class A" Liquor 3. License to sell alcoholic beverages under Chapter 125, Wis. Stat., issued by the West Allis Common Council.
- That Dilneet Corporation is the holder of a Cigarette and Tobacco Products License 4. to sell cigarette and tobacco products under Chapter 139, Wis. Stat., issued by the West Allis Common Council.
- That Dilneet Corporation is the holder of a Food-Related Permit/License to sell food 5. under Chapter 75 of the Wisconsin Agriculture, Trade & Consumer Protection Code,

- issued by the West Allis Common Council.
- That Dilneet Corporation does business under the trade name "West Allis Liquor & 6. Tobacco."
  - That Rupinder Randhawa (hereinafter "Randhawa") is the agent of Dilneet Corporation's above-referenced licenses/permits. 7.
  - That due to non-payment of real estate taxes and non-compliance with the West Allis Revised Municipal Code in regard to the building code, Dilneet Corporation has not been eligible for renewal of its licenses or permits since the 2011-2012 license year, 8. but has been operating, at various times, due to its entering into a payment agreement with the City in September 2011 and, eventually, paying off its delinquent real estate taxes.
    - That on or about August 6, 2013, the Wisconsin Department of Revenue notified the West Allis City Clerk's office that Dilneet Corporation did not possess a valid 9. seller's permit and could not sell any retail goods. See attached Exhibit 1.
      - That on September 5, 2013, Wisconsin Department of Revenue Agent Georgeann King (hereinafter "King") performed an inspection of West Allis Liquor & Tobacco 10. and discovered that the business was operational and selling alcoholic beverages despite having a revoked seller's permit.
        - That King also discovered that the "Class A" Beer and "Class A" Liquor license for Dilneet Corporation had been altered to show that it was issued on June 30, 2013 and 11. expired on June 30, 2014, when in fact, no such license had ever been issued. See
          - That due to the business not having a valid seller's permit, King required Dilneet attached Exhibit 2. Corporation to shut down its operations at that location until its permit was 12. reinstated.

- 13. That the Wisconsin Department of Revenue reported to the West Allis City Clerk's office on September 9, 2013 that Dilneet Corporation could re-open West Allis Liquor & Tobacco due to its reinstating its seller's permit.
- 14. That on October 15, 2013, due to a prior summons and complaint issued against
  Dilneet Corporation for failure to pay its real estate taxes, the West Allis Common
  Council approved a Findings and Recommendations in regard to that summons and
  complaint that revoked Dilneet Corporation's licenses. See attached Exhibit 3.
- 15. That on October 16, 2013, Assistant City Clerk Monica Schultz mailed Dilneet Corporation a letter informing it that the Common Council had revoked its licenses and it could no longer engage in licensed activity. See attached Exhibit 4.
- 16. That on October 18, 2013, at approximately 4:00 p.m., West Allis Police Sergeant Trever Pasdera entered West Allis Liquor & Tobacco and discovered that the business was open and engaged in licensed activity.
- 17. That Sergeant Pasdera spoke with Randhawa, who stated that she had received the letter from Monica Schultz at 11:00 a.m. that same morning and had continued engaging in licensed activity despite the revocation of the licenses.
- 18. That Sergeant Pasdera required Randhawa to shut down the business, and West Allis Police Officer Megan Primising issued her a citation for selling alcoholic beverages without a license.
- Tobacco, by agent Rupinder Randhawa, substantially relates to the licensed activity and is contrary to Wisconsin Statutes Sections 77.52(12), 125.04(1) and 943.38(1), West Allis Revised Municipal Code Section 9.02(12)(d), and is grounds for non-renewal, suspension, or revocation of its "Class A" beer license, "Class A" liquor license, tobacco license, and food-related permit/license.

WHEREFORE, Michael J. Czaplewski, requests that Dilneet Corporation, doing business as West Allis Liquor & Tobacco, by registered agent Rupinder Randhawa, be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the "Class A" beer license, "Class A" liquor license, tobacco license, and food-related permit/license of Dilneet Corporation should be revoked, suspended, or not renewed.


