I am requesting to destroy the following records in accordance with City of West Allis Revised Municipal Code Section 1.09 and subject to approval by the State of Wisconsin Historical Society.

## Record

Property File information (paper) retained after purging as stated in my recent correspondence to you dated February 1, 2007 (copy attached). This file information includes all permit applications, issued building permits, correspondence, Board of Appeals, building plans with related information, property maintenance Notice/Orders and court cases, all being related to the property file. This includes building permit records from Milwaukee County (township permits) before incorporation as a village, to 1924 when the department started keeping records, up to June 1, 2007, when the department anticipates beginning optical scanning of all file information.

All this file information will be retained by optical scanning of all file information and then destroying all file information. The records will be stored on CD's for future retrieval as well as within a City owned and maintained computer server.
