**RESOLUTION RELATIVE TO APPROVING A SECONDARY LOCATION FOR 1840
BREWING COMPANY**

WHEREAS, 1840 Brewing Company is a state-permitted brewery that maintains its primary location at 342 E. Ward St., Milwaukee, WI; and

WHEREAS, Wis. Stat. 125.29(7)(b) allows brewers to engage in full-service retail sales at off-site locations with the approval of the municipality in which those sales take place; and

WHEREAS, 1840 Brewing Company has committed to its second year of sponsorship of the City of West Allis' Summer Concert Series, a City-sponsored event; and

WHEREAS, the Summer Concert Series will be held on Thursdays, June 20, July 18, August 22 and September 19, 2024 at Veterans Memorial Park, 70th and National Avenue; and

WHEREAS, as part of the sponsorship agreement, 1840 Brewing Company seeks permission to establish a full-service retail outlet at Veterans Memorial Park, 70th and National Avenue, to sell alcohol beverages during the Summer Concert Series dates of June 20, July 18, August 22 and September 19, 2024; and

WHEREAS, 1840 Brewing Company is a sponsor in good standing whose support and partnership is essential to the execution of this vibrant community event.

NOW THEREFORE, BE IT RESOLVED by the City of West Allis that a full-service retail outlet is approved for 1840 Brewing Company as part of the Summer Concert Series at Veterans Park, effective on June 20, July 18, August 22 and September 19, 2024.


