Resolution relative to the City of West Allis  
Expressing opposition to the proposed  
City of Milwaukee Downtown Streetcar Project  
Should Costs be Incurred to Non-City of Milwaukee Utility Users.

WHEREAS, the City of Milwaukee has proposed the construction of a Downtown Streetcar Project; and,

WHEREAS, said project will cost an estimated \$64 million for the two mile route from the Intermodal Station on St. Paul Avenue through the Third Ward and downtown Milwaukee; and,

WHEREAS, the cost estimate does not include a possible addition of \$50 million dollars or more for the cost of relocating underground utilities for WE Energies, AT&T, and Time Warner; and,

~~WHEREAS, the fixed route project has a much higher initial capital cost and annual operating cost than a more flexible, less expensive rubber-tired trolley bus system; and,~~

WHEREAS, if the Wisconsin Public Service Commission determines that the relocation costs of the underground utilities are the utility companies' expenses, they would then be incorporated into their new rates and charges to non-City of Milwaukee ~~individuals and businesses~~ utility users.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that it hereby expresses its opposition to the proposed project if utility and/or utility ~~the~~ relocation costs ~~of the underground utility companies~~ are paid for in full or in part by non-City of Milwaukee ~~individuals and businesses~~ utility users.

BE IT FURTHER RESOLVED by the Common Council of the City of West Allis that a copy of this Resolution shall be sent to Milwaukee Mayor Tom Barrett, the Milwaukee Common Council, the Wisconsin Public Service Commission, WE Energies, AT&T, Time Warner Cable, and the Milwaukee Metropolitan Chamber of Commerce.
