The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of October.

Incident reports:

Case #13-9054, 10/05/2013, at 0237 hrs. – 6139 W. Beloit Rd, Whammy Bar

On 10/05/2013, at 0237 hrs., Officers responded to 6139 W. Beloit Rd, Whammy Bar tavern, for a report of a trouble call. Investigation revealed intoxicated guitarist of the band Cyanide Sunrise, Jason Zaharick, playing at the establishment this evening, was involved in a confrontation with tavern employee, Peter W. Grubor, on the east side of the bar. Zaharick yelled obscenities at Grubor, created a disturbance, threw a chair, and followed after Grubor once Grubor attempted to go back inside this tavern, He attempted to gain entry in an effort to continue to engage in a confrontation with Grubor, kicked through the tavern door, continued to yell obscenities and create a disturbance until police arrived. Zaharick was taken into custody for Disorderly Conduct, booked and issued a Municipal Citation for Disorderly Conduct and released.

Case # 13-009496, 10/18//2013, at 1613 hrs – 7218 W. Greenfield Av., West Allis Liquor & Tobacco

On 10/18/2103, at 1613 hrs, Officers stopped and checked to see if West Allis Liquor and Tobacco were still operating after having their license revoked. They found the business open and selling alcoholic beverages to a customer as the Officer walked into the business. The owner, Rupinder K. Randhawa was advised to close the business, due to the fact she had received a letter from the City on October 16th, advising her that effectively immediately she may no longer engage in Licensed activity. Randhawa showed the Officer the actual letter she received from the City and he pointed out to her that right in the letter it advises her she may no

longer engage in licensed activity. The store was shut down and a citation was mailed to the owner for Selling Alcoholic Beverages without a Class A Liquor License. She was advised not to open the store until the matter had been resolved.

The business was checked on 10/20/2013 and 10/22/2013 and both times it was closed for business.

Case # 13-009583, 10/21/2013, at 0122 hrs – 9440 W. National Av., Brooklyn's

On 10/21/2013 at 0122 hrs., Officers responded to 9440 W. National Av, Brooklyn's for a report of four patrons assaulting Brooklyn's staff. Contact was made with four parties across the street from Brooklyn's. These parties began to actively fight Officers. K-9 was also called. Two of the parties backed off, however, the other two continued to resist Officers. The K-9 was ordered to bite one of the Offenders in the calf. This didn't seem to faze the Offender. West Allis Rescue responded and transported. The altercation began over payment of a lap dance. All four parties were arrested for Disorderly Conduct, Battery and Resisting. The Bartender called and stated once the disturbance moved outside she watched it on the security camera screen. Once again, video surveillance was not available for evidence.

Case # 13-009585, 10/21/2013, at 0503 hrs – 9440 W. National Av., Brooklyn's

On 10/21/2003, at 0503 hrs., Officer made contact with one of the Offenders in the previous complaint. The now victim, stated after being released from the police station, he walked back to his vehicle, which was parked in the parking lot at Brooklyn's. He observed that his two rear tires were slashed. Both rear tires on the vehicle appeared to have a knife mark near the bottom of each tire. He suspects an employee of Brooklyn's slashed his tires after his arrest. Brooklyn's employee advised he did not think the video surveillance was working, but would check with the owner of Brooklyn's. The video surveillance was never made available.

Case # 13-009786, 10/27/2013, at 0047 hrs – 1309 S 60 St., Remedy

On 10/27/2013, at 0047 hrs., Officers responded to 1309 S. 60 St., Remedy regarding a male subject with a knife. Investigation revealed an unknown offender was urinating on a vehicle outside the tavern. When confronted, the subject brandished a knife and fled in a vehicle. Officers conducted a traffic stop of the vehicle. The driver was arrested for OWI. The passenger was arrested for Possession of a Controlled Substance –THC. Both subjects were the suspects in the initial altercation at Remedy.

Case # 13-009788, 10/27/2013, at 0121 hrs – 7527 W. Becher St, Flappers Tavern.

On 10/27/2013, at 0121 hrs., Officers responded to 7527 W. Becher St, Flappers Tavern for a report of a female patron who would not leave and had also pushed another patron. Officers made contact with Gerole L. Cszaszar, who was highly intoxicated and was unable to give a statement at the scene. Officers spoke with patron, Ashley E. Brockman, who stated she was inside of Flappers when she and Gerole exchanged words. The bartender asked Gerole to leave. Approximately 1-2 hours later, Gerole was walking outside past the bar when Ashley was

outside. Gerole had pushed Ashley in her shoulder. Ashley was adamant that she wanted Gerole arrested for her actions. The Officer detected a strong odor of intoxicants emitting from Ashley, who was talking very loud and slurring her words. Ashley admitted to the Officer that she was intoxicated. Gerole was arrested, book, cited for Disorderly Conduct and released.
