SUMMARY

Officer Vanden Boogard reports.... *Shots Fired*

On 12/29/19 at approximately 0001hrs, the WAPD received numerous calls of 5-6 gunshots heard in the area of 65/Beloit. Officers canvassed the area and did not locate any evidence. A witness observed a red older model Honda Civic and another unknown make/model vehicle, speeding away eastbound on W. Beloit Rd. during the time of the gunshots but it is unknown if these vehicles were related. Contact with the bartender at the Alibi tavern was made however the owner refused to come to the business to provide video surveillance. A report for record was generated.

INITIAL RESPONSE

CONTACT WITH CALLER

I made contact with Kaylenn A. Sacasa, F/W [REDACTED]. She was inside her residence which is on the west side of the residence. She heard 5-6 gunshots and believed they were within a block or two. Her window faces west and she believed they came from the west or north. She did not observe any suspicious vehicles or people outside. She did not have any further information regarding this incident.

AREA CANVASS

Myself and other officers walked several alleys and streets within the immediate area but no evidence was located.

After I made contact with Joni, I conducted a search of the alley behind her residence. I did not locate anything suspicious during my search.

I briefly made contact with the occupants of a dark colored SUV who were parked on S 66th St in front of the Alibi.

The vehicle was occupied by three females who said they just arrived here and did not hear or see anything. I went inside the bar to check if everything was alright, however Officer Jacobsen was already talking to the bartender so I left and continued checking the area.

Cpt. C. Marks assigned this case to me.

The difference in time between the interior video provided by The Alibi bar and the exterior video is about 3:20 minutes; the interior view is 3:20 faster than the exterior views.

VIDEO REVIEW--OUTSIDE BAR

Cpt. Marks provided two DVDs with working copies of surveillance video from this case. I watched the first video which contained surveillance video from outside of The Alibi bar.

Timestamp: 12/28/2019 11:55:04 PM

CAM01 shows front of bar looking down at the intersection of S. 66 St. and W. Grant St. with W. Beloit Rd. in the background. For reference, the bar's exterior sign in on the left side and a fire hydrant in the sidewalk is on the right side. The time stamp starts at 11:55 and the date is 12/28/2019. The lighting is provided by street lights, the roads are wet and there is rain falling. At 11:55:33 and at 11:56:02 I hear some indistinct sound.

At timestamp 11:58:40 a white male with white hair wearing a dark coat and dark pants walks out of the bar and west on W. Grant St. At 11:57:25 the male can be seen in the very lowest right corner can be seen heading north out of the door and the video cuts off at 0000 hrs.

The second video, also on CAM01, picks up at 0000 hrs. on 12/29/2019. At timestamp 12:01:15 a West Allis Police SUV is seen arriving.

The third video, CAM02, starts at 1155 hrs. and shows the west side of the building along S. 66 St.

At timestamp 11:57:25 PM a figure runs northbound on S. 66 St. and heads toward a spot in the street. A female figure with long blonde hair, carrying a jacket and backpack runs in the same direction, but stops short. She runs back toward the bar, followed by the male. The clothing seen on the male and female are consistent with the male and female seen in the bar, especially the male seen handing a handgun off to the bartender, Melissa M. Bayer.

The actual shooting appears to happen in a space outside in front of the bar that is not covered by surveillance video.

She returns at 11:56:27 PM looking at her cell phone the entire time.

Bayer is back behind the bar. No one else has moved. Nothing of note.

At 11:58:25 the female half of the couple goes to the juke box which is on a platform next to the front door. The older male goes to the back where the pool table is. Bayer is still behind the bar, gives some cash to the younger male and points towards the south. He takes the cash and gestures toward the front door. Bayer peers out the front window.

The younger male walks to the girl at the jukebox and kisses her. She continues to look through the jukebox. The girl then looks through the door and points in a southwest direction. A car goes by south on S. 66 St. The male points in the girls face. The male looks out the door and Bayer peers out the front window.

The younger male runs out of the front door; the female stays by the inner door of the door. Bayer stays behind the bar. The female appears to be yelling out of the door.

12:00:20 AM The female walks out front door; they both run in about five seconds later.

12:00:34 AM The couple returns to the bar and the man gestures they should follow him to the back of the bar.

12:00:45 AM Bayer tries to prevent the male from leaving back out the front door, but he does anyway.

12:01 Bayer comes back into the bar with her hands on her head.

12:01:27 The male hands the gun to Bayer. The older white male is back at the end of the bar and witnesses everything that happens.

12:01:56 AM The younger male dumps the gray hooded sweatshirt with yellow sleeves behind the bar. Bayer gets a blue jacket out of a cabinet behind the bar and hands it to the younger male.

12:02:48 AM Male runs back into the bar and back past pool table.

CONTACT WITH PATRICK KOSIDOWSKI OWNER OF ALIBI BAR**12/31/2019**

I first spoke to Patrick Kosidowski by telephone. He said a group of about 12 people came into the bar during the evening. They appeared to be celebrating a birthday party and they "looked normal" according to Kosidowski. The first he found out about the incident was when the bartender, Melissa Bayer, called him and told him that someone had fired shots into the air outside of the bar.

Det. Vanderwerff and I went to the area of the Alibi bar to look for bullet strikes and any other pertinent evidence that may have been overlooked during hours of darkness. We found nothing. I noticed a man walking into the Alibi bar and we went into the bar. I spoke to Patrick Kosidowski, the owner of the bar. He gave us verbal consent to look around the back of the bar, but I found nothing of evidentiary value.

Kosidowski said he couldn't provide a cell phone number for Melissa Bayer because he believes she is having problems with her cell phone.

FURTHER CONTACT**01/02/2020**

I met with Patrick and Tammy Kosidowski first at the police department, where I took their fingerprints and obtained buccal samples for comparison purposes should it become necessary. I then met with them at the Alibi bar and collected

Bayer's string bag she left behind the bar when she was arrested. I also collected two cell phones, a gold Apple iPhone and a black cell phone with a cracked screen.

Tammy told me when Bayer called her immediately after the shooting, Bayer only told her the police needed access to the surveillance system, not that there had been a shooting and that's why Tammy and Patrick did not respond immediately.

Tammy said when she talked to Bayer later on Sunday, December 29, 2019, Bayer told Tammy about the shooting, but claimed she thought the sounds were fireworks, not gunshots.

STATEMENT OF MELISSA BAYER**01/02/2020**

I spoke to Melissa Bayer in interview room B of the detective bureau.

Seccond statement

SEARCH OF BAYER'S CELL PHONE

After Bayer signed the *Consent to Search* and provided the access code of 0000, I handed the phone over to Sgt. Treep for download. This phone is an Apple iPhone 7; Bayer said her boyfriend, Nidal Salem, provided to the phone to her. The other phone I recovered when I collected the items from The Alibi, was able to be powered on, but it requires a pass code.

Sgt. Treep started looking through the phone and found that many of the most recent text messages had been deleted. He looked through the deleted pictures photos and found screen shots of messages between Bayer and a man with the name William J. Unk at 0243 hrs. Sunday. The message read, " I know u don't , that's why I'm saying you gotta be smarter then that. I know you just you and some shit popped off n you look out trying to hide the pistol. Look that some down ass shit to do, some good looking out type shit. But not at your job on camera baby. We both know you smarter than that already." In a message with a time at 09:37 AM Monday William texts, "Apparently they got permission to look at cameras because police downstairs by themselves(no rick or tammi) for like 30 minutes. Then female cop came upstairs behind bar shining flashlight all where you be keeping your purse and bag and shit. So I don't know what they looking at for sure downstairs, but they ain't got no other reason to be down there by themselves. You need to talk to rick and/or tammi tomorrow afternoon and see if they know or heard anything from the police. The female cop was a tall ass white chick so I do know if that's they same one from yesterday or not, but she was a big bitch."

On Saturday at 11:02 PM Bayer took a picture of a person holding a gun pointing down. The handgun is a Taurus with a laser pointer. Sgt. Treep and I were able to find the serial number. Sgt. Treep was able to read the serial number, run it through the Taurus web site and found it to be consistent with the model shown in the picture.

NIBINS**01/02/2020****IDENTIFICATION OF CAYLA CLARK AND LUIS M. HERNANDEZ****01/06/2020**

I requested Cpt. S. Beyer create a Facebook post requesting information leading to the identification of the three people of interest in this case: the female, the younger male, and the older male witness.

Almost immediately my phone started to ring and ultimately I received almost three dozen telephone calls with tips. The overwhelming majority of callers identified Cayla Clark as the female in the Alibi Bar. In fact, her probation agent, Heather Wagner, called and we discussed the case and the fact that many people, including police officers, identified Cayla Clark as the woman in the Alibi Bar during this incident.

STATEMENT OF CAYLA CLARK**01/06/2020**

Cayla Clark eventually called me herself and agreed to come into the police department and discuss the case with me. She did arrive at about 1600 hrs. and I spoke to her in the meeting room adjacent the front complaint desk.

Clark said she was all at the bar and she told officers when they asked if she heard anything, she told them she hadn't. She said the bartender was "super" drunk. Clark said she didn't know what happened but all of a sudden the bartender started freaking out and started putting things behind the bar, including a sweater. I asked where the sweater came from and Clark said she didn't know. At this point I told Clark that there was very good video in the bar that showed everything and that I didn't feel she was being entirely truthful with me.

I asked her the identity of the guy she was with that night. She said, "Luis." I asked for his full name and she said she thought it was Hernandez. She said they just started talking, which I interpreted to mean started dating recently. She said she didn't know what he did because he went out and came back in and

then said abruptly that they were leaving the bar and then he took an Uber home.

Again I reiterated she wasn't being truthful. She said she didn't know what happened when Hernandez walked outside of the bar. I asked why she would give her key to someone she hardly knows and she stopped and said, "Stupidity." She said he was going to her house to change. She provided the telephone number of 414-469-6159 and his Facebook name as "Rowdy Rab." She was not able to provide a birth date for Hernandez but she did say he lived in St. Francis. She thought he was 24 years old.

Clark denied knowing what Hernandez was doing when he ran into the middle of the street toward to the man hole cover and denied picking up empty shell casings. She said she doesn't know what bullet casings look like. She also claimed she didn't know Hernandez was carrying a gun even though he was openly carrying the gun on his hip.

She told me they got to the bar around 8:00 p.m. to 9:00 p.m. She admitted to drinking Corona. She thought they paid cash for their drinks. The bartender did ask about the sweat shirt Hernandez was wearing, which is something Bayer said happened. Clark also said she and Hernandez did not know Bayer before the night of this incident.

I asked her why when she was standing and looking at the juke box, she started looking out of the glass door and pointing. She said she thought she saw the Mazda vehicle she shares with her former boyfriend, Miguel Diaz, drive down S. 66 St. She said it out loud. She said Diaz is now in custody after a high speed chase during a weekend chase one week after this incident.

I asked what Clark was doing when she is shown in the video leaning out the inner door of the entrance/exit. She said she was probably asking Hernandez what he was doing. She said he then ran into the bar and started exchanging the gun and clothing.

Clark said Hernandez works at Tax Air on the docks as a forklift operator. She works at Tax Air as a first shift dispatcher. She told me Tax Air in on Howell Ave.

STATEMENT OF WITNESS--RUDI E. NAUMANIS

Rudi E. Naumanis responded to the police department in response to the Facebook posting and subsequent news reporting. I spoke to him at the complaint desk and he identified himself with a Wisconsin driver's license.

He said he went into the bar intending to have a drink. He said the bartender was acting "weird" and was focused on the other two people in the bar, totally ignoring him. He went to the bathroom and when he came out the atmosphere in

the bar had totally changed. The bartender and the "guy" were yelling at each other. The bartender was yelling "no no no no no" at the guy and grabbed his sweatshirt. Naumanis said he couldn't remember what else they were yelling and decided just to leave because he wasn't getting any service.

CONTACT WITH LUIS HERNANDEZ

Amongst all the other calls I received regarding this case, I received a voicemail message from a man identifying himself as Luis Hernandez and left the telephone number 414-469-6159.

01/07/2020

I spoke to Luis Hernandez by telephone. He said he was willing to come in and talk to me and that he has talked to his boss already about the issue. I received a text message about 2116 hrs at home saying that Hernandez had come to the police department and was in custody.

01/08/2020

I spoke to Luis Hernandez in interview room B of the detective bureau. The start time is noted in the Phoenix system as 09:25:02 hrs. and ends at 09:51:40 hrs. I started by asking pedigree questions. Hernandez is originally from Chicago. He moved to Wisconsin eight months ago and lives with his father. Both he and his father work for Tax Air. He has one sister who lives in Wisconsin, more sisters in Chicago, and his mother and brother live in Florida.

He has a diploma from a trade school in Joliet, Illinois. He reads, writes, and understands the English language.

I asked him what his understanding of the incident was. He said he was at the bar with a friend (Cayla), and he had a few drinks. He said, "I had my gun on me." He said stepped outside to smoke a cigarette he "got excited" and discharged his weapon into the air. Hernandez said it was a really dumb decision. He said the weapon held 12 rounds and he thought he discharged 11 of them. He identified the weapons as a 9mm Taurus that he bought in Illinois within the past year.

Immediately after the shooting, he said he realized he had really screwed up and thought about his dad and young daughter. He ran into the bar and exchanged his sweatshirt with the bartender and he ran out of the bar. He later tossed the gun into a commercial dumpster in the area of S. 13 St. and W. Lincoln Ave.

I asked about his interaction with Bayer outside of the bar. He said he was openly carrying the gun and Bayer was interested in it so he showed it to her. He said she continued to serve him alcohol even after seeing he was armed with a handgun. He said they were drinking Jameson whiskey and had a couple of
