**RESOLUTION ACCEPTING WORK OF C.W. PURPERO, INC. FOR URBAN SOIL  
DECOMPACTION AND AUTHORIZING AND DIRECTING SETTLEMENT OF  
SAID CONTRACT IN ACCORDANCE WITH CONTRACT TERMS OF 2024-2 FOR  
FINAL PAYMENT OF \$26,620.00**

**WHEREAS**, C.W. Purpero, Inc. has completed their contractual obligations in accordance with the plans and specifications therefore, attested by the approval for payment by the City Engineer.

**NOW THEREFORE**, be it resolved the Common Council of the City of West Allis that the work of C.W. Purpero, Inc. (2024 Project No.2) for excavation to prepare for a soil study by stripping the topsoil, applying 4-inches of compost to surface, excavating 24-inches of subsoil, incorporating compost into subsoil, breaking apart clumps and loosening the soil, placing salvaged topsoil and topsoil, tilling soil to break the interface between the topsoil and subsoil layers, planting woody plants, trees or shrubs at W. Orchard St. from 350-feet east of S. 108 St. to S. 108 St. dead end is accepted, and the proper City officers are authorized and directed to make settlement with the said contractor in accordance with terms of said contract.
