COMPLAINT

Theodore Atkinson, being duly sworn, on oath deposes and states as a complaint against D&G Investments, LLC, (hereinafter "D&G"), d/b/a Mobile Estates of West Allis, c/o Thaddeus Derynda and Bernie Gallas, agents, as follows:

- 1. That the complainant is a resident of the City of West Allis, is the director of the City of West Allis Building Inspection and Neighborhood Services Department, and makes this complaint at the direction of the License and Health Committee of the West Allis Common Council.
- 2. That the information contained in this complaint comes from the complainant's review of official records maintained by the City of West Allis, which records complainant believes to be reliable and accurate.
- 3. That D&G is the holder of a Mobile Home Park License, License Number 290, to operate a mobile home park under West Allis Revised Municipal Code Section 9.21(2)(b), issued by the West Allis Common Council on June 19, 2012.
- 4. That D&G does business under the trade name "Mobile Estates of West Allis."
- 5. That the agents for D&G are Thaddeus Derynda and Bernie Gallas.
- 6, That on August 5, 2009, Plumbing Inspector Michael Scherer inspected the property

- at 10401 West Greenfield Avenue and observed several violations of the state and local plumbing codes.
- 7. That on August 21, 2009, Inspector Scherer issued a notice and order to D&G to correct the violations. (See attached Exhibit 1.)
- 8. That subsequent inspections from Atkinson and Plumbing Inspector Michael Romens revealed that D&G has not corrected the following state Safety and Professional Services (hereinafter "SPS") code violations: 382.30 (10)(a)(1), 382.30 (10)(b)(2)(a), 382.30 (10)(b)(2)(b), 382.30 (10)(b)(2)(c), 382.30 (10)(b)(2)(d), 382.30 (10)(b)(3), 382.30 (10)(b)(4)(b), 382.30 (10)(b)(4)(c). (See attached Exhibit 2.)
- 9. That D&G has not been fully compliant with the SPS code since prior to Inspector Scherer's inspection on August 5, 2009.
- 10. That D&G's failure to corrects its code violations substantially relates to the licensed activity contrary to West Allis Revised Municipal Code Section 9.21(2)(f) and is grounds for non-renewal, suspension, or revocation of its Mobile Home Park License.

WHEREFORE, Theodore Atkinson requests that D&G, d/b/a Mobile Estates of West Allis, c/o agents Thaddeus Derynda and Bernie Gallas be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the Mobile Home Park license of D&G Investments, LLC should be revoked, suspended, or not renewed.
