NOTICE OF HEARING

The Common Council of the City of West Allis will hold a Public Hearing on March 18th, 2008, at 7:00 p.m., or as soon thereafter as the matter may be heard, in the Common Council Chambers of the City Hall, 7525 West Greenfield Avenue, West Allis, Wisconsin, upon the Resolution herein described and will act upon said Resolution at said time and place. Said Resolution was introduced into the Common Council of the City of West Allis on January 15th, 2008, and proposes the vacation and discontinuance of a portion of South 91st Street South of West Mitchell Street, legally described as follows:

That portion of South 91st Street as mapped, platted and dedicated as part of Assessors Plat No. 255, Block 3, being a duly recorded subdivision of a portion of the Northwest ¼ of Section 4, Township 6 North, Range 21 East, in the City of West Allis, Milwaukee County, State of Wisconsin, more particularly described as follows:

Beginning at the Northeast corner of Lot 11; Block 3 of said Assessors Plat No. 255; thence Easterly, 60.00 feet along the South right-of-way line of West Mitchell Street to the Northwest corner of Lot 10 in Block 3 of said Assessors Plat; thence Southerly, 120.00 feet along the East right-of-way line of South 91st Street; thence Westerly, 60.00 feet to the West right-of-way line of said South 91st Street; thence Northerly, 120.00 feet along said West right-of-way line to the Point of Beginning.

Description contains 7200.00 square feet, more or less.
