Dear Friend:

As you are aware, Congress recently passed the American Recovery and Reinvestment Act, which pledges nearly \$900 billion to help bolster our nation's sagging economy. Of that amount, \$150 billion will be invested in improving our nation's crumbling infrastructure. Investing that kind of money for repairing our roads and bridges will create many new jobs in our state and its communities. Jobs that are needed now, with unemployment nearing double digits.

Included in the Act is language that closes loopholes in often ignored "Buy American" legislation that has been the law in our country for over 70 years. The new language directs state, county and local governments to buy American made goods and services for all projects funded with stimulus (taxpayer) money. There are certain cases that will allow governments to seek a waiver from the "Buy American" provisions. However, the bill's intent is to encourage the purchase of American made goods to get our manufacturing sector back to work again.

Attached you will find a copy of a Buy American Resolution that the United Steelworkers are asking state, county and local governments to pass in support of the legislation. While it is non-binding, the resolution acknowledges the importance of buying locally, where money will be spent to spur economic growth and create additional jobs. It just doesn't make sense to use American taxpayer dollars to support steel mills in China, cement foundries in Mexico, or construction equipment producers in Japan.

A member of the United Steelworkers, who resides or works within your community, will be contacting you to ask for your support of the resolution. We ask that you pass it on to your town council for a vote at an upcoming meeting. The Steelworkers thank you for your consideration in this matter and look forward to discussing it with you.

THEREFORE,

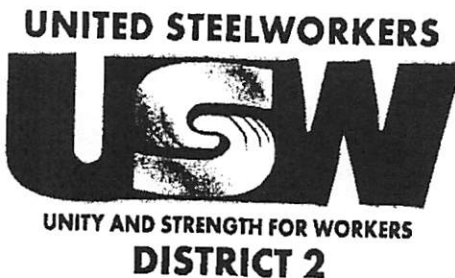
