Sir,

On 10/29/02, between 1842 and 2145 hrs, I conducted a Tavern Compliance Check with the aide of a 18year-old West Allis resident, Jon R. Nelson. In this compliance check, Jon entered 21 West Allis taverns and he attempted to purchase a Miller Lite beer without providing identification. Of the 21 taverns entered, the following 9 taverns sold alcohol to Jon without requesting identification:

#### **CASE SYNOPSIS**

PO Johnson reports...

On 10/29/02, between 1842 and 2145 hrs., "Jon", an 18-year-old West Allis resident, assisted me in a Tavern Compliance Check. Jon entered and attempted to purchase alcohol at 21West Allis taverns. He attempted to purchase a Miller Lite beer without identification. Of the 21 taverns entered, Jon was able to purchase alcohol at 9 of the taverns without being asked for identification. At each of the 9 offending taverns, the bartender that sold the alcohol to Jon was cited, along with the tavern's license holder. In cases where the bartender was also the license holder, only 1 citation was issued. All citations were mailed on 11/01/02.

## COMPLIANCE CHECK PROCEDURE

Before beginning the compliance check, Jon was photographed, asked to empty his pockets (excluding money needed), and given a detailed and complete set of instructions. Jon was given money provided by the department and was advised to enter each tavern and attempt to purchase a Miller Lite beer. Jon was advised that if the bartender requested identification, he was to immediately exit the tavern.

I was in plain clothes and entered each tavern with Jon. I viewed each transaction as it was conducted. Jon remained in my view at all times, with each transaction being entirely witnessed by me. Upon receiving the alcohol, Jon paid for it immediately. He was then advised to enter the men's bathroom area and dispose of some of the beer before exiting the bathroom. While Jon was in the bathroom, I asked the bartender his/her first name. Jon would come back to the bar, set his beer on it and we would exit the tavern. At all the taverns, we walked in together and sat next to each other. I did not order anything to drink.

#### **INCIDENT**

At approx. 1915 hrs., we entered O'Connor's Perfect Pint tavern. A male bartender, identified as "Paul", sold Jon a glass of Miller Lite beer without requesting ID. After receiving the beer, Jon walked into the bathroom and poured some of the beer out. He placed the half empty glass of beer on the bar before leaving the tavern with me.

At approx. 1920 hrs., we entered **State Fair Inn** tavern. A male bartender requested identification from us. We told him we did not have any and immediately exited the tavern

At approx. 1922 hrs., we entered **Painted Parrot** tavern. A female bartender requested identification from us. We told her we did not have any and immediately exited the tavern.

At approx. 1930 hrs., we entered **Tomken's** tavern. A female bartender, identified as "Brandi", sold Jon a glass of Miller Lite beer without requesting ID. After receiving the beer, Jon walked into the bathroom and poured some of the beer out. He placed the half empty glass of beer on the bar before leaving the tavern with me.

At approx. 1934 hrs., we entered **The Drum** tavern. A female bartender requested identification from us. We told her we did not have any and immediately exited the tavern.

At approx. 1942 hrs., we entered **The Derby** tavern. A female bartender, identified as "Sharon", sold Jon a glass of Miller Lite beer without requesting ID. After receiving the beer, Jon walked into the bathroom and poured some of the beer out. He placed the half empty glass of beer on the bar before leaving the tavern with me.

At approx. 1945 hrs., we entered **Walk Her Inn** tavern. A male bartender requested identification from us. We told him we did not have any and immediately exited the tavern.

At approx. 1947 hrs., we entered **Korbelly's** tavern. A male bartender requested identification from us. We told him we did not have any and immediately exited the tavern.

At approx. 2000 hrs., we entered **Phylo's** tavern. A female bartender, identified as "Lou", sold Jon a glass of Miller Lite beer without requesting ID. After receiving the beer, Jon walked into the bathroom and poured some of the beer out. He placed the half empty glass of beer on the bar before leaving the tavern with me.

At approx. 2010 hrs., we entered **The Dog House** tavern. A male bartender requested identification from us. We told him we did not have any and immediately exited the tavern.

At approx. 2012 hrs., we entered **Duke's** tavern. Jon recognized and personally knew the female bartender. Jon did not attempt to purchase alcohol and we exited the tavern.

At approx. 2018 hrs., we entered **Midnight Express** tavern. A female bartender, identified as "C - C", sold Jon a bottle of Miller Lite beer without requesting ID. After receiving the beer, Jon walked into the bathroom and poured some of the beer out. He placed the half empty bottle of beer on the bar before leaving the tavern with me.

At approx. 2024 hrs., we entered **Deja Vu** tavern. A male bartender requested identification from us. We told him we did not have any and immediately exited the tavern.

At approx. 2027 hrs., we entered **Rider's Inn** tavern. A bartender requested identification from us. We told him/her we did not have any and immediately exited the tavern.

At approx. 2030 hrs., we entered **Bennett's** tavern. A female bartender, identified as "Shannon", sold Jon a can of Miller Lite beer without requesting ID. After receiving the beer, Jon walked into the bathroom and poured some of the beer out. He placed the half empty can of beer on the bar before leaving the tavern with me.

At approx. 2055 hrs., we entered **Randy's Neighbor's Inn** tavern. A female bartender, identified as "Suzy", sold Jon a mug of Miller Lite beer without requesting ID. After receiving the beer, Jon walked into the bathroom and poured some of the beer out. He placed the half empty mug of beer on the bar before leaving the tavern with me.

At approx. 2100 hrs., we entered **Mary's on the Corner** tavern. A female bartender requested identification from us. We told her we did not have any and immediately exited the tavern.

At approx. 2107 hrs., we entered **Becher Street Bar & Grill** tavern. A male bartender, identified as "Bob", sold Jon a glass of Miller Lite beer without requesting ID. After receiving the beer, Jon walked into the bathroom and poured some of the beer out. He placed the half empty glass of beer on the bar before leaving the tavern with me.

At approx. 2110 hrs., we entered **Happy Dav'z Pub** tavern. A male bartender requested identification from us. We told him we did not have any and immediately exited the tavern.

At approx. 2119 hrs., we entered **Greg's Place** tavern. A female bartender, identified as "Judy", sold Jon a glass of Miller Lite beer without requesting ID. After receiving the beer, Jon walked into the bathroom and poured some of the beer out. He placed the half empty glass of beer on the bar before leaving the tavern with me.

At approx. 2124 hrs., we entered **Wild Bill's Saloon** tavern. A female bartender requested identification from us. We told her we did not have any and immediately exited the tavern.

#### FOLLOW - UP

On 10/30/02, follow up was attempted at the 9 offending taverns.

Contact was made at Becher Street Bar & Grill. The bartender, Robert C. Niehoff, informed me that he was not only the bartender, but also the license holder. Robert stated he remembered me and recognized the male in the Polaroid. Robert stated that he was thinking to himself about four times that night that he should ask for our ID's. Robert was cooperative and stated, "Thanks for keeping us honest." I advised Robert that he would receive a citation in the mail for Selling Alcohol to an Underage Person.

Contact was made at Bennett's. The License Holder was on scene and identified himself as David M. Bennett. David stated the bartender was Shannon M. Kling. I telephoned Shannon and advised her of the incident. She stated she remembered me coming in, along with the male party. They were both cooperative. I advised David and Shannon that they would each receive a citation in the mail for Selling Alcohol to an Underage Person.

Contact was made at The Derby. The bartender, Sharon M. Alexander, stated she remembered me and recognized the male in the Polaroid. She informed me that the license holder is Lois NMI McHugh. I contacted Lois and advised her of the incident. They were both cooperative. I advised Sharon and Lois that they would each receive a citation in the mail for Selling Alcohol to an Underage Person.

Contact was made at Greg's Place. The bartender, Judith L. Falesnik, stated she remembered me and recognized the male in the Polaroid as the one she served a beer to. She informed me that the license holder is Gregory G. Strong. I advised Gregory of the incident, who was also at the tavern. I advised Greg and Judith that they would each receive a citation in the mail for Selling Alcohol to an Underage Person.

Contact was made at Midnight Express. The bartender identified the license holder as Dale J. Zbieranek. I called Dale and advised him of the incident. He identified C-C as Carol L. Torres. I called Carol and advised her of the incident. Carol stated she remembered us and serving the male a beer. She stated she was sorry. They were both cooperative. I advised Dale and Carol that they would each receive a citation in the mail for Selling Alcohol to an Underage Person.

Contact was made at Phylo's. The same bartender was working, Lois H. Lehmann. Lois stated she remembered me and remembered serving the person in the Polaroid. Lois said she was the license holder, however, in checking our contacts, the license holder is Philip J. Lehmann. I called Philip and advised him of the incident. I advised Lois and Philip that they would each receive a citation in the mail for Selling Alcohol to an Underage Person.

Contact was made at Randy's Neighbor's Inn. The bartender identified Suzy as Suzanne M. Katzuba. I called Suzanne and advised her of the incident. She stated she remembered me coming in with the male in the Polaroid and serving him a beer. Suzanne stated she is part owner of the bar, but her husband, Randal W. Katzuba is the license holder. I advised her that she and Randal would each receive a citation in the mail for Selling Alcohol to an Underage Person.

Contact was made at Tomken's. The license holder, Kenneth W. Felton, was on scene. I advised him of the incident. He identified Brandi as Brandi M. Nehmer. Kenneth was very uncooperative, stating this was

entrapment and bullshit. I called Brandi and she stated she remembered us coming in and serving the male a beer. Brandi stated, "I knew I should have carded him." Brandi was cooperative. I advised Kenneth and Brandi that they would each receive a citation in the mail for Selling Alcohol to an Underage Person.

#### **CASE DISPOSITION**

Incident reviewed with Lt Morrissey.

After all follow-up was completed, each offender was mailed a citation for Selling an Alcoholic Beverage to an Underage Person via US Mail and given a local court date of 12/02/02 at 0830 hrs.
