All meetings, unless otherwise noted, are open to the public and may be televised and recorded through the City's Cable Communications Division.



NARRATIVE

Officer Foy reports...

DISPATCH TO CALL/ARRIVAL ON SCENE

On 12/30/14 at 2205hrs officers responded to Oval Bar, 9141 W National Ave, for a report of a male that broke a glass and was threatening patrons. Officers arrived and were unable to locate the male. Suspect was wearing a camouflage jacket, blue jeans and red knit hat.

STATEMENT OF COMPLAINANT - JENNIFER BRUMER

The bartender, Jennifer M Brumer, F/W 5/10/71, advised she has never met the male before but heard his name was "Jacob". Brumer stated she stopped serving the male because he appeared to be highly intoxicated. Brumer stated the male became extremely upset and began to yell. Brumer stated the male was making threats stating that he "killed people" and that he was going to kill everyone there.

Brumer advised the male exited the bar and she last observed him walking E/B on W National Ave. Brumer advised she did not want him arrested for the \$3 in damaged drink glass and the threats. Brumer advised that if located, "Jacob" is to be banned from the bar.

LACK OF CONSENT

Brumer stated she did not give the individual consent to break the glass, however she did not want anything done regarding the damage.
