2. [24-0523](#) Appeal of Dangerous Dog Order for Scooby by Austin Long issued on August 21st, 2024, at 8705 W. Dakota St. (AARB-19)

Clark moved to uphold the Dangerous Dog order for the dog "Scooby" owned by Austin Long with the requirements listed within the dangerous dog order issued by the Police department. In addition, Scooby must attend a training program. If no further violations arise and conditions are met, owner may petition to lift the order in one year, beginning September 16, 2025, Ald. Weigel seconded, motion carried.
