WHEREAS, Canine KC and Corporal Douglas Sayeg have participated in numerous narcotics seizures, tracking of suspects, building searches and demonstrations for the community,

WHEREAS, Canine KC and Corporal Douglas Sayeg are a well-respected Canine team in the State of Wisconsin and have been excellent ambassadors for the West Allis Police Department and City of West Allis,

WHEREAS, Canine KC and Corporal Douglas Sayeg's professionalism has been recognized by the Wisconsin Law Enforcement Canine Handlers Association as K-9 Handler of the Year award in 2025,

WHEREAS, Canine KC was sadly diagnosed with cancer and had to be retired from police service. Canine KC retired from police service on October 24th, 2025,

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that Canine KC be given as a gift, to Corporal Douglas Sayeg with the obligation that Corporal Sayeg assume future costs, liabilities and responsibilities associated with Canine KC.


