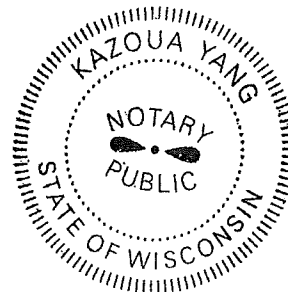

NOTICE IS HEREBY GIVEN that the Common Council will conduct a public hearing in the Common Council Chambers of West Allis City Hall, 7525 West Greenfield Avenue, West Allis, Wisconsin, on Tuesday, January 15, 2019, at 7:00 p.m., or as soon thereafter as the matter may be heard, upon:

- 1) Amendment to the FY2015-2018 Community Development Block Grant Action Plan, B-18-MC-55-0011, to allocate \$259,327 of contingency funds and \$289,286 of FY2018 unallocated new funds for a total funding of \$548,613
- 2) Amendment to the FY2015-2018 Community Development Block Grant Action Plan, B-18-MC-55-0011, relative to creating a 2018 92nd Street Plaza project with a budget of \$40,000 from 2018 CDBG funds and contingency funds.
- 3) Amendment to the FY2015-2018 Community Development Block Grant Action Plan, B-18-MC-55-0011, relative to creating a 2018 Farmers Market Lead Abatement project with a budget of \$350,000 from 2018 CDBG funds and contingency funds.
- 4) Amendment to the FY2015-2018 Community Development Block Grant Action Plan, B-18-MC-55-0011, relative to creating a 2018 Liberty Heights Park Improvement project with a budget of \$150,000 from 2018 CDBG funds and contingency funds.
- 5) Amendment to the FY2015-2018 Community Development Block Grant Action Plan, B-18-MC-55-0011, relative to creating a 2018 Economic Development project with a budget of \$8,613 from 2018 CDBG funds and contingency funds.

The purpose of this public hearing is to provide interested citizens an opportunity to express their views on the allocation and use of CDBG funds and to provide citizens with information on how these funds are to be utilized.
