Michael J. Czaplewski, being duly sworn, on oath deposes and states as a complaint against 3M Management, LLC as follows:

1. That the complainant is a resident of the City of West Allis, is the duly elected Alderperson for the First Aldermanic District in the City of West Allis, is the Chairman of the License and Health Committee, and makes this complaint at the direction of the License and Health Committee of the West Allis Common Council.
2. That the information contained in this complaint comes from the complainant's review of official records maintained by the City of West Allis and the Wisconsin Department of Revenue, which records complainant believes to be reliable and accurate.
3. That 3M Management, LLC is the holder of "Class B" Intoxicating Liquor & Class "B" Fermented Malt Beverage License Number 14-1931, Instrumental Music License Number 14-2064, and Dance Hall License Number 14-2063, issued by the West Allis Common Council for the license period beginning July 1, 2014, and ending June 30, 2015, for the premises located at 1900 South 60th Street, West Allis, Wisconsin and does business under the trade name "M&M's Sportsbar."

4. That 3M Management, LLC is the holder of a Local Food Permit, issued by the West Allis Health Department for the permit period beginning July 1, 2014, and ending June 30, 2015, for the premises located at 1900 South 60th Street, West Allis, Wisconsin and does business under the trade name “M&M’s Sportsbar.”
5. That Melissa Marie Martin is the agent of 3M Management, LLC’s above-referenced licenses and permits.
6. That on June 3, 2014, Martin signed an operation plan for M&M’s Sportsbar and agreed, among other things, to comply with Chapter 125 of the Wisconsin Statutes and all ordinances of the West Allis Revised Municipal Code. See attached Exhibit 1.
7. That on January 21, 2013, West Allis Health Department Environmentalist Laura Temke inspected the premises and completed a pre-inspection report for M&M’s Sportsbar. Temke wrote in the comments section of the report that the bar could not supply food to the public at any time, except for candy, chips, popcorn, and wrapped beef jerky. A copy of the report was provided to 3M Management, LLC. See attached Exhibit 2.
8. That a review of M&M’s Sportsbar’s Facebook page indicated that the bar hosted a pig roast on October 20, 2013; hosted its 2nd annual chili cook off on March 9, 2014; advertised Bari’s pizza on September 4, 2014; advertised free food during the Packers game on December 8, 2014; and advertised free food on New Year’s Eve 2014. See attached Exhibit 3.
9. That on January 15, 2015, Temke performed a food inspection at M&M’s Sportsbar and noted crock pots in the back room, along with party trays. Temke also noted signs for Bari’s Pizza – a pizza business that is next door to the bar, but is not a licensed wholesaler – that indicated M&M’s Sportsbar was serving Bari’s Pizza.

Temke took photos of the sign and crock pots. Due to the violations, Temke issued a cease and desist order to M&M's Sportsbar.


10. That on January 23, 2015, Agent Georgeann King from the Wisconsin Department of Revenue, along with West Allis police officers, investigated a complaint of M&M's Sportsbar refilling liquor bottles.
11. That Agent King's investigation revealed that she found 106 bottles of liquor inside the bar, but Martin could not produce any receipts from licensed wholesalers for the liquor.
12. That Agent King recovered three receipts from Discount Liquor, a business that is not a licensed wholesaler, that indicated purchases of several bottles of liquor. The receipts were located on the licensed premises, and Martin admitted that she had purchased the liquor from Discount Liquor. See attached Exhibit 4.
13. That Agent King also recovered the following beer receipts: a receipt from Discount Liquor for a barrel of Coors Light and Miller Lite and receipts from Beer Capitol and Beechwood from July and August 2014. Martin could not produce any additional beer receipts.
14. That Agent King discovered two contaminated liquor bottles that contained bugs and noticed several full bottles of liquors had a worn out label. Based on her training and experience, King knows that full bottles with worn out labels are indicators of refilling.
15. That upon confronting her with the information about the refilling of bottles in the back office, Martin initially denied that she had refilled liquor bottles. However, eventually, Martin admitted to West Allis Police Officer Jason Komorowski that she had refilled some of the liquor bottles.
16. That during her contact with Martin, Agent King noted that Martin was untruthful

with her on several occasions; Martin initially told King that she had purchased the liquor from Ratas Wholesale, but later admitted to purchasing liquor from Discount Liquor; Martin initially told King that her alcohol receipts were behind the bar, but none were located there; that Martin initially denied refilling liquor bottles, but later admitted that she had refilled liquor bottles.


17. That 3M Management, LLC has violated the provisions of Chapter 125, Wis. Stats., including Wis. Stat. §§ 125.51(3)(b); 125.68(8)(a)2-3; and 125.69(6)(a); and Wisconsin Stat. § 946.41(1); the Wisconsin Administrative Code, Department of Revenue, Tax § 7.01(4); and sections 7.04(11), 7.04(14)(d), 9.02(12)(b) and 9.02(12)(d) of the West Allis Revised Municipal Code; that the conduct substantially relates to the licensed/permitted activity; and the conduct is grounds for non-renewal, suspension, or revocation of its Class B” Intoxicating Liquor License, Class “B” Fermented Malt Beverage License, Instrumental Music License, Dance Hall License, and Local Food Permit.

WHEREFORE, Michael J. Czaplewski requests that 3M Management, LLC be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the “Class B” Intoxicating Liquor License, Class “B” Fermented Malt Beverage License, Instrumental Music License, Dance Hall License, and Local Food Permit should be revoked, suspended, or not renewed.

OPERATION PLAN

WHEREAS, on September 18, 2012, a summons and complaint alleging violations of Wisconsin Statute Chapter 125 and West Allis Revised Municipal Ordinance 9.02(12) was filed with the West Allis Common Council's License and Health Committee in regard to Danny's Lounge, located at 1900 South 60th Street, West Allis, Wisconsin; and

WHEREAS, on November 20, 2012, the West Allis Common Council approved a stipulation that prohibited Danny's Lounge from operating under its tavern licenses until a new occupant applied for a tavern license; and

WHEREAS, Melissa Marie Martin who is the registered agent of 3M Management, LLC (hereinafter "Martin"), seeks to obtain a tavern license for the premises at 1900 South 60th Street under the name of 3M Management, LLC; "Martin", when used herein, shall mean Melissa Marie Martin, in her individual capacity, as well as 3M Management, LLC; and

WHEREAS, on prior occasions, complaints were filed with the West Allis Common Council's License and Health Committee regarding taverns located at 1900 South 60th Street, West Allis, Wisconsin, including "Mario's" and "Kicks"; and

WHEREAS, due to the prior incidents at the location, the City wishes to protect the health, safety, and welfare of its citizens and employees before agreeing to license a tavern at that location; and

WHEREAS, to achieve those objectives, the Common Council is requesting a suitable operation plan from Martin, as a condition of granting her a tavern license application; and

WHEREAS, on December 18, 2012, Martin agreed to and signed an operation plan which restricted her from obtaining a Dance Hall license, Tavern Entertainment license and Instrumental Music license at the premises; and


WHEREAS, at this time, Martin is requesting permission from the License and Health Committee and Common Council to be granted a Dance Hall license and Instrumental Music license with the renewal of her Class B Tavern application for the 2014-2015 license year; and

WHEREAS, since the signing of the Operation Plan by Martin on December 18, 2012, there have been no incidents of a negative effect at or on the premises.


WHEREFORE: Melissa Marie Martin, and 3M Management, LLC, doing business as M&M's Sports Bar, hereby agrees to the following revised operation plan for the licensed premises at 1900 South 60th Street:

1. That Martin shall be eligible for a dance hall license, pursuant to West Allis Revised Municipal Ordinance 9.05, with the renewal of her Class B Tavern license for dancing only to occur on Wednesdays, Fridays and Saturdays on any given week.
2. That Martin shall not be eligible for a tavern entertainment license, pursuant to West Allis Revised Municipal Ordinance 9.034;
3. That Martin shall be eligible for an instrumental music license, pursuant to West Allis Revised Municipal Ordinance 9.032, for music to only occur on Wednesdays, Fridays and Saturdays of any given week, but Martin shall not permit any DJs, or other similar entertainment, including but not limited to, Karaoke to perform at the premises. "DJ," as used herein, shall mean a person who plays, presents, or mixes recorded music typically for dancing or a party, but shall not include a person selecting recorded music from a jukebox, iPod, computer, or similar device; "Karaoke", as used herein, shall mean a form of interactive entertainment or video game, in which amateur singers sing along with recorded music using a microphone and public address system, whereby the lyrics are displayed on video screen to guide the singer.
4. That Martin shall not employ or partner with Mario Morgese, Daniel Seiy, or any former licensee of 1900 South 60th Street to operate or assist in operating the premises;
5. That Martin shall maintain a theme of a "sports bar" at the premises;

6. That Martin, the employees of 3M Management, LLC, and the employees of M&M's Sports Bar shall comply with all other state statutes, including but not limited to Wis. Stat. Chapter 125, and all ordinances in the West Allis Revised Municipal Code.
7. That these restrictions may not be altered without the consent of the License and Health Committee of the West Allis Common Council.
