
PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are

PART III. This ordinance shall take effect and be in force from and after its passage and publication.



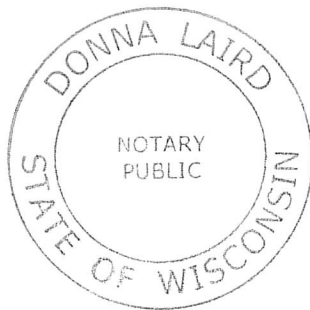
