RESOLUTION R-2024-0489**

**RESOLUTION RECOGNIZING THE FAIRVIEW PARK NEIGHBORHOOD
ASSOCIATION, ESTABLISHING BOUNDARIES, AND AUTHORIZING AN
ORGANIZATIONAL GRANT UP TO \$1,000**

WHEREAS, the Mayor and Common Council of the City of West Allis, along with its staff and residents, recognize the importance of developing and maintaining healthy neighborhoods throughout the community; and,

WHEREAS, the Fairview Park Neighborhood Association ("FPNA") has been organized by residents and business owners of the City of West Allis to promote and sustain the highest standards in preservation of their neighborhood, and address the issues of safety, social engagement, and neighborhood improvements within its designated boundaries; and,

WHEREAS, the FPNA will serve residents in its area extending from the Hank Aaron Trail on the north, to Greenfield Avenue on the south, west to 77th Street, and east to 70th Street, as further described in the attached Boundary Map Exhibit A; and,

WHEREAS, R-2014-0099 established a Neighborhood Grant Program to provide small grants to help organize neighborhood associations and to promote neighborhood enhancement projects and the grant application submitted by the FPNA (attached within Exhibit A) meets the criteria of the West Allis Neighborhood Small Grant Program.

NOW THEREFORE, NOW THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that:

1. The FPNA is fully formed and officially recognized under the neighborhood association guidelines that were adopted with R-2014-0092 (Neighborhood Association Policies and Procedures).
2. The Mayor, Common Council, and staff of the City of West Allis hereby pledge their support and cooperation in addressing the needs of the residents of this neighborhood and the community in general.
3. The boundaries of the FPNA are accepted as illustrated in Map Exhibit A.
4. A one-time organizational grant to the FPNA of up to \$1,000 is approved to cover costs of community engagement and membership building activities, including beautification improvements to Kopperud Park, a neighborhood block party, and meetings to plan community engagement activities.
5. The Mayor or his designee is authorized to enter into a grant agreement by and between the City of West Allis and FPNA for the project amount requested of up to \$1,000.

BE IT FURTHER RESOLVED that this resolution shall be in full force and effect from and

after its passage and approval.
