The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of January.

Incident reports:

Case #14-11607, 12/30/2014, 0055 hrs: 6426 W. Greenfield Av – Spot Lite (Late reporting)

On 12/30/2014, at 1548 hrs., a victim came into the station to report she was physically assaulted by another dancer while at the Spot Lite. The altercation began with the other dancer yelling at her, then the offender began pushing and punching the victim, resulting in multiple contusions and laceration on her face, along with a broken finger. The case was reviewed at the District Attorney's Office and the Offender was charged with Battery.

Case #15-224, 01/02/2015, 1548 hrs: 6200 W. Greenfield Av - Six Points Pub & Grill

On 01/02/2015 at 1548 hrs., Officers responded to Six Points Pub & Grill for a male party smashing a window. Investigation revealed a party was intoxicated and fell into the front picture window, causing the window to break. The party was arrested and given a local citation for Disorderly Conduct. He was found to be on probation so a hold was placed on him. After being booked, he was conveyed to the County Justice Facility.

Case #15-1319, 01/10/2015, 0100 hrs., 5732 W. Mitchell St – Tap 58

On 01/10/2015, at 0100 hrs, a bar patron came into the station to report her wallet was stolen from her purse while she was at Tap 58. The patron had \$90 cash inside, with numerous other cards. She left her purse on a chair at the bar and covered it with a jacket and does not suspect anyone specific.

Case #15-2607, 01/18/2015, 2324 hrs., 5732 W. Mitchell St - Tap 58

On 01/18/2015, at 2324 hrs, Officers responded to Tap 58 for an attempted armed robbery. Officers learned two males entered the tavern, pointed a handgun at numerous people inside, and demanded money from the bartender. The suspects left when no items were received and fled north on foot. Officers were not able to locate the offenders. Surveillance video was not recording at this time.

Case #15-2511, 01/18/2015, 0154 hrs., 7731 W. Becher St – Quenchers

On 01/18/2015, at 0154 hrs., Officers responded to Quenchers for a trouble call in regard to a group of male parties fighting. Investigation revealed two parties got into a physical altercation with several males inside the bar. One party held a knife to a bar patron's throat. The two Offenders were arrested and taken into custody.

Case #15-3315, 01/23/2015, 1503 hrs., 1900 S. 60 St - M&M's Bar

On 01/23/2015, at 1503 hrs., Officers responded to M&M's Bar with Officer King of the Dept of Revenue in a bar check. Investigation revealed several liquor laws were broken and all liquor bottles were confiscated. Also during the investigation, Bruce E. Hicklin was being uncooperative. Officers discovered he had a local final commitment. He was arrested, booked and posted bail.

Case 15-4354, 01/30/2015, 1332 hrs: 7408 W Walker St - Gussler's

On 01/30/2015, at 1332 hrs, Officers conducted a tavern check at Gussler's, 7408 W Walker St and made contact with the bartender. When asked to see their license, she showed him an expired tavern license. The bar owner indicated he applied for the license but had not picked the license up from City Hall. Contact was made with City Hall, who indicated the owner applied for a liquor license in Sept 2014, but was not approved, as he had not fulfilled the requirements to obtain the license.

Tobacco and Alcohol Compliance checks:

• No violations reported during this reporting period.

Violation of Wisconsin Clean Air Act Smoking Ban:

• Case 15-4449, 01/31/2015, 0011hrs: 5632 W Burnham St – 57 Bar
On 01/31/2015, Officers responded to the 57 Bar regarding an anonymous complaint of patrons smoking inside the tavern. Officers found a patron to be smoking inside the tavern. Contact was

made with the bartender who stated she knew smoking inside the tavern was illegal, but stated she was in the bathroom and did not know the patron was smoking. The bartender and patron were issued a verbal warning. The current liquor license was not posted.
