**FINDINGS OF FACT:**

1. That Gregory Steffek was served a copy of the summons and complaint;
2. That Gregory Steffek, by Attorney Joseph Redding, stipulated to the complaint and, thus, the allegations in the complaint are considered to be true;
3. That the conduct of Gregory Steffek d/b/a Mugshotz described in the complaint substantially relates to the alcohol beverage licensed activity contrary to Wis. Stat. § 125.04(5)(b);


