**RESOLUTION TO APPROVE THE BID OF FORWARD CONTRACTORS OF
WISCONSIN INC. FOR SIDEWALK REPAIR IN THE GENERAL AREA BOUNDED
BY S. 108TH ST. TO WEST CITY LIMITS AND SOUTH CITY LIMITS TO THE
UNION PACIFIC RAILROAD IN THE AMOUNT OF \$171,565**

WHEREAS, The Board of Public Works reports that it duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in a certain area as hereinafter described; that the bids received were reasonable and hereby recommends and deems it to be for the best interests of the City of West Allis that the bid of Forward Contractors of Wisconsin Inc. for 2026 Project No. 1 be accepted.

NOW THEREFORE, be it resolved by the Common Council of the City Of West Allis that the bid of Forward Contractors of Wisconsin Inc. for 2026 Project No. 1 for the replacement or repair of concrete sidewalk in:

General Area Bounded by S. 108th St. to West City Limits and South City Limits to
Union Pacific Railroad

for the sum of One Hundred Seventy-one Thousand, Five Hundred Sixty-five and no/100 dollars (\$171,565) be accepted, and the proper City officers are hereby authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

BE IT FURTHER RESOLVED That said improvements be installed with funding by Bond Funds and special assessments. 350-6008-531.31-01
