WHEREAS, the City is considering vacating and discontinuing a portion of the alley east of South 65th Street between West Greenfield Avenue and West National Avenue.

NOW, THEREFORE, BE IT RESOLVED that the Notice of Hearing, a copy of which is attached hereto, for the vacation and discontinuance of a portion of the alley East of South 65th Street between West Greenfield Avenue and West National Avenue, be published in the official City newspaper, the JournalSentinel, on July 9, 2003, July 16, 2003 and July 23, 2003; that the Hearing be scheduled before the Common Council on August 5, 2003 at 7:00 p.m., or as soon thereafter as the matter may be heard; that a copy of the aforesaid Notice be served or mailed more than thirty (30) days prior to the Hearing in the manner prescribed by the law on the owners of all of the frontage of the lots and lands abutting upon the said portion of alley proposed to be discontinued.


