RESOLUTION R-2024-0297**

**RESOLUTION TO AUTHORIZE THE PURCHASE OF TWO (2) 2024 FORD SUPER
DUTY F-250 PICK-UP TRUCKS FROM EWALD AUTOMOTIVE GROUP,
HARTFORD FOR A SUM OF \$87,801**

WHEREAS, the Department of Public Works Forestry Division is in need of replacing two (2) 21 and 23 year old vehicles with many maintenance issues with new, more efficient, and functional vehicles; and,

WHEREAS, the 2024 approved budget includes \$90,000 for the purchase of the two (2) new vehicles; and,

WHEREAS, Ewald Automotive Group has provided pricing for the 2024 pick-up trucks for the Department of Public Works of the City of West Allis utilizing the State of Wisconsin Contract for Autos and Trucks; and,

WHEREAS, the Fleet Services Division of the Department of Public Works has determined that this contract meets all desired specifications, and that the proposal received is reasonable; and,

WHEREAS, the Common Council deems it to be in the best interests of the City of West Allis that the proposal of Ewald Automotive Group be accepted.

NOW THEREFORE, Be It Resolved by the Mayor and Common Council of the City of West Allis that the proposal dated May 23, 2024 by Ewald Automotive Group, Hartford for furnishing and delivering two (2) 2024 Ford Super Duty F- 250 pick-up trucks for a total net sum of \$87,801 be and is hereby accepted.

Now, Therefore, Be It Resolved by the Mayor and Common Council of the City of West Allis that the purchase of the above described items, for an amount of \$87,801, is hereby authorized. Funding for these two (2) purchases has been budgeted and is available in the 2024 Capital Improvement Program budget in the amount of \$87,801. These purchases will be charged to Account Number 352-4301-533.70-03.

Be It Further Resolved that the Finance Department be and is hereby authorized to enter into a contract for the aforesaid equipment.
