During the second quarter at the bequest of the Cable Communications Coordinator the WACCC and its members were encouraged to contact their Congressional Representatives concerning legislation before the House.

This year is the WACCC's 25th anniversary and they are developing promos and a special dinner to commemorate the event.

Twenty workshops/training classes were held in the second quarter. Seven for Producers, four in field production, five in studio operations and four on the computer editing. Also 50 programs were produced during this period and five new members joined the WACCC.

It is staff's recommendation that the second quarter operating funds be allocated to the WACCC.
