**RESOLUTION TO ACCEPT THE PROPOSAL OF UNIVERSAL TRUCK
EQUIPMENT FOR FURNISHING AND DELIVERING TWO 11-FOOT HEAVY
TRUCK PLOWS FOR A TOTAL OF \$36,418**

WHEREAS, the Public Works Sanitation and Streets Division is replacing its 25-year-old Hustling-style snowplows with modern Pin & Loop-style plows as older trucks are phased out; and

WHEREAS, item #37 in the 2026 Capital Improvement Program approved budget includes \$45,000 for the purchase of two 11-foot heavy truck plows; and

WHEREAS, Universal Truck Equipment has provided pricing for two 2026 Universal CST 11-foot heavy truck plows using Minnesota DOT Contract# 267382; and

WHEREAS, the Public Works Fleet Services Division has determined that this proposal meets all desired specifications and that the proposal received is reasonable; and

WHEREAS, it is in the best interests of the City of West Allis that the proposal of Universal Truck Equipment be accepted.

NOW THEREFORE, be it resolved by the Common Council of the City Of West Allis that the proposal dated August 3, 2026 submitted by Universal Truck Equipment for furnishing and delivering two new Universal CST Pin & Loop 11-foot heavy truck snowplows for a total of \$36,418 is accepted.

BE IT FURTHER RESOLVED that this purchase will be charged to Account Number 352-4218-535.70-03.

BE IT FURTHER RESOLVED that the Finance Department is authorized to enter into a contract for the aforesaid equipment.

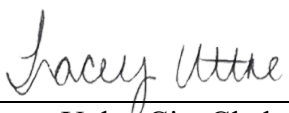

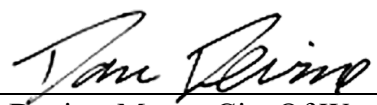
