The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of April 2011.

## **Incident reports:**

Case 11-002774, 03/30/11 at approx. 2000hrs. Barnecks Bar, 7411 W. Becher St.

On the above date and time, there was a physical altercation between two female patrons in Barnecks Bar – 7411 W. Becher St. Statements from witnesses and the parties involved indicate that a female patron pulled the hair of another female patron causing her to fall to the ground. The owner of the bar was on scene and failed to notify police of this physical altercation, which resulted in two citations being issued for disorderly conduct. In addition, a witness indicated that patrons were allowed to smoke in the back room of the tavern, which apparently is near the kitchen area.

## Case 11-002794, 04/01/11 at 0220hrs. Las Palmas, 6007 W. Burnham.

On the above date and time, Officer McNally responded to a call at Las Palmas regarding patrons in the tavern after hours. Upon arrival Officer McNally observed three parties drinking drinks at the bar (Officer McNally witnessed these parties drinking for approx. 5 minutes before he entered the bar). Parties were issued citations for remaining on a license premise after closing. The owner was issued a citation for remaining open after closing hours.

### Case 11-003016, 04/08/11 at 0206hrs. Double Barrel Saloon, 1100 S 60 St.

On the above date and time, officers were dispatched to the 1000 blk of 58<sup>th</sup> St for a loud vehicle complaint. Upon Officer Kuhnmuench arrival he observed several parties outside milling around the north side of the Double Barrel Saloon, located at 1100 S 60<sup>th</sup> St. Officer Kuhnmuech addressed these parties in effort to learn if this was the source of his noise complaint and also to disperse them from the area. While addressing these individuals one party became belligerent and disorderly in nature (swearing and giving Officer Kuhnmuench the finger repeatedly). After several warnings were given to this individual to leave the area, he failed to comply and continued being belligerent toward Officer Kuhnmuench. Officer Kuhnmuench subsequently arrested him for Disorderly Conducted.

## Call # 11-014055, 04/09/11 at 0212hrs. HEROS Bar, 9105 W. Lincoln Ave.

On the above date and time, Officers responded to a trouble call at Heros Bar, 9105 W. Lincoln Ave. There was a report of several parties fighting. Upon officers arrival there was no fight; however, several parties were standing outside the bar. All parties were sent on their way.

### Call # 11-014058, 04/09/11 at 0219hrs. Jock Stop Sports Bar, 7930 W. National Ave.

On the above date and time, Officers were dispatched to a trouble call at the Jock Stop Sports Bar, 7930 W. National Ave. There was a report of several parties fighting outside the bar. Upon officers arrival no one was located outside. Bar staff reported that parties fled before officers arrived.

## Case 11-003095, 04/10/11 at 0037hrs. Crazy Horse Gentlemen's Club, 9442 W National.

On the above date and time, Officers responded to the Crazy Horse Gentlemen's Club for a report of an out of control employee. Investigation revealed that a female employee was belligerent, yelling obscenities and thrashing around; in addition, she kicked and spit on the security employees, as well as exposing her bare breasts. This individual was also belligerent towards officers; she was subsequently arrested and issued a citation for disorderly conduct.

## Call # 11-015510, 04/17/11 at 2314 hrs. Wild Bill's Saloon, 1454 S. 92nd St.

On the above date and time, Officers were dispatched to Wild Bill's Saloon for a noise complaint. Upon officer's arrival, no parties were observed outside the tavern; however, loud music and singing was coming from the inside of the bar. The bartender was contacted and advised of the complaint. The bartender respectfully apologized, and said people were singing Karaoke and that she would turn the volume down on the speakers.

## Case 11-003339, 04/17/11 at 0126hrs. Danny's Lounge, 1900 S 60th St.

On the above date and time, Officers responded to Danny's Lounge, 1900 S. 60<sup>th</sup> St for a report of a fight. Investigation revealed that two parties began fighting inside the bar, which was forced outside by the security personnel; at which point several other parties joined in the assault / fight. One party was knocked unconscious during the altercation. No arrests were made at the time of the initial investigation, due to parties fleeing before officer's arrival and lack of cooperation from witnesses.

# Call # 11-015527, 04/18/11 at 0155 hrs. Wild Bill's Saloon, 1454 S. 92nd St.

On the above date and time, Officers were dispatched to Wild Bill's Saloon for a complaint of loud people who were making noise by screeching their tires and whatever else they could make noise with. Officers reported no one around upon their arrival.

## Call # 11-015690, 04/19/11 at 0051 hrs. Flapper's Bar, 7527 W. Becher St.

On the above date and time, officers were dispatched to Flapper's bar regarding smokers being loud outside the bar. Officers spoke with the complainant who said the smokers were no longer causing a disturbance and the bar has been doing a good job keeping the noise down the past few months; however, the complainant wanted the incident documented and the bar's staff advised of the complaint. The bartender was contacted and said she would ask her patrons to smoke on the west side of the building when going outside to smoke.

#### Call # 11-015818, 04/20/11, 0131 hrs. Flapper's Bar, 7527 W. Becher St.

On the above date and time, officers responded to Flapper's bar regarding a male who fell in the street. Investigation revealed a male patron was highly intoxicated and fell in the street. A female party subsequently assisted the male subject getting home.

## Case 11-003757, 04/30/11 at 0216hrs. HEROS Bar, 9105 W. Lincoln Ave.

On the above date and time, officers responded to HEROS Bar, located at 9105 W. Lincoln Ave for a report of approx. twenty people fighting in the bar. Upon officers arrival there were approx. 15 people standing around outside the bar, but no fighting. According to one bouncer there were several fights that began inside the bar. He attributed the fights to one person who was getting the entire crowd rowdy (this is the person who officers ended up arresting for D/C – he was yelling loudly and very belligerent toward officers).

#### **Tobacco and Alcohol Compliance checks:**

No alcohol compliance checks were performed in the month of April. Violation of Wisconsin Clean Air Act Smoking Ban;

There was one (1) reported violation for the month of April.

Case 11-003577, 04/24/11 at 1909hrs. Harry O'S Tavern, 6743 W. Lincoln Ave.

On the above date and time, Officer Matter responded to Harry O'S tavern on an anonymous complaint that the bartender was unlicensed and smoking cigarettes in the bar. Investigation revealed that the bartender admitted she smoked two cigarettes in the bar, but was licensed; however, she did not have her license on her person or in the bar. The licensed owner was subsequently contacted and responded to the bar; he said he would stay behind the bar during this bartender's entire shift. A citation was issued to the bartender who admittedly was smoking in the bar.
