**RESOLUTION TO APPROVE THE BID OF CW PURPERO FOR THE
ENVIRONMENTAL REMEDIATION SERVICES ON THE TRANSFER STATION
SITE AS PART OF THE NEW DPW FACILITY PROJECT**

WHEREAS, the Board of Public Works reports that it duly received a bid from CW Purpero for the performance of all work required for the improvements in a certain area as hereinafter described; that the bid received as shown on the attached bid report was at the same unit prices as is the publicly bid prices for the environmental remediation of the adjacent Teledyne site, and CW Purpero is the current contractor for the environmental remediation on the former Teledyne site which was publicly bid and awarded are reasonable and hereby recommends and deems it to be for the best interests of the City of West Allis that the bid of CW Purpero be accepted.

NOW THEREFORE, BE IT RESOLVED By the Common Council of the City of West Allis that the bid of CW Purpero for the environmental remediation and related work for the West Allis Department of Public Works located at:

for the sum of approximately One Hundred Forty Three Thousand and 00/100 dollars (\$143,000.00) be accepted, and the proper City officers are hereby authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal; and,

BE IT FURTHER RESOLVED, that primary funding for this project was approved in the 2022, 2023, and 2024 Capital Budgets. Sources of funds include an allocation from the federal ARPA grant, cash on hand in capital projects and utility funds, as well as debt financing. Costs will be charged under project number NEWDPW, unless otherwise assigned by the Finance Department.

BE IT FURTHER RESOLVED that the City Engineer be and is hereby authorized to make such non-substantive changes, modifications, additions and deletions to and from the various provisions of the Agreement, including any and all attachments, exhibits, addendums and amendments, as may be necessary and proper to correct inconsistencies, eliminate ambiguity and otherwise clarify and supplement said provisions to preserve and maintain the general intent thereof, and to prepare and deliver such other and further documents as may be reasonably necessary to complete the transactions contemplated therein.
