An Ordinance to Amend Subsection 15.03(4)(b) and 15.03(4)(c) of the West Allis Revised Municipal Code Relating to changing four family residents with private recycling collection services being exempt from the City Waste Management fee, and to require all four family residences to be charged a recycling fee on a quarterly basis

The Common Council of the City of West Allis do ordain as follows:

Part I. Subsection 15.03(4)(b) and 15.03(4)(c) of the Revised Municipal Code of the City of West Allis is hereby amended to read

- (b) Rates. The Common Council will establish rates for each fiscal year. All rates established by the Common Council will be fair and reasonable and calculated to achieve a balanced operating budget for the program. Current rates will be on file in the office of the City Clerk/Treasurer.
- (c) Billing Schedule. The billing schedule is as follows:
