A group of people, including Barbian, went up the pet the dog. Blawat stated his dog bite Barbian while she was bending over near the dog's face. Blawat stated he did not think the injuries were significant and returned to his residence. Blawat stated his dog has never done anything like this before and he did not know what to do. Blawat and I filled out the Order Dangerous Dog and Suspect Rabies Report on scene. Blawat confirmed the dog is up to date on its vacancies and has never shown signs of illness in the past.

Investigation revealed the owner of the dog is Jeffrey J. Blawat (M/W, DOB 09/09/76) and contact was made at his residence. Blawat signed the dangerous dog form and the suspect rabies form.

NARRATIVE

CALL FOR POLICE

On 05/25/13 at approx. 0205 hours, officers responded to Aurora West Allis Medical Center (8901 W. Lincoln Ave.) at the request of medical staff who indicated a female was bitten by a dog at O'Connors Perfect Pint (8423 W. Greenfield Ave.). Upon arrival, contact was made with Brittany L. Barbian in emergency room number 16. Barbian was sitting up on the edge of the medical bed holding a towel to her face due to the fact it was bleeding from the bites.

ON-SCENE STATEMENT-BRITTANY L. BARBIAN-VICTIM

Barbian stated she was at O'Connors Perfect Pint with her boyfriend, Dale B. Raatz. While they were at the tavern an unknown subject brought a rottweiler inside. Numerus people went up to pet the dog and Barbian joined them. As Barbian was standing over the top of the dog it bit her in the face unprovoked. Barbian stated she did not do anything to the dog which would illicit a bite response.

Afterwards, she went over and sat down on a chair holding her face. Raatz asked her what happened and she stated she was bit by the dog. As a result of the dog

bitting Barbian's face, she suffered injuries to her upper lip and nose, which started to bleed. Barbian stated it also caused her a good amount of pain. Eventually they went to Aurora West Allis Medical Center to seek treatment where medical staff called for the police to respond.

LACK OF CONSENT

Barbian did not give consent to be bitten by the rottweiler.

ON-SCENE STATEMENT-DALE B. RAATZ-CONTACT

Raatz stated he saw a subject bring a rottweiler in the tavern and numerous people went up to pet it. Raatz stated he was on the other side of the bar when he saw Barbian sitting on the chair holding her face. Raatz asked Barbian what happened and she informed him the dog bit her in the face. Raatz looked around and saw the owner and dog had already left the tavern. Raatz stated they went to Aurora West Allis Medical Center for treatment.

Raatz informed me he is friends with the owner of O'Cooner's Perfect Pint, Michael C. O'Connor. Michael texted him and stated the subject who brought the dog in the tavern might possibly be a Jeff Blawat. I gave Raatz a business card with the case number on it before leaving the room.

INJURIES/PHOTOGRAPHS

I observed Barbian's upper lip had a laceration as well as lacerations on the her nose. I did not observed any other injuries at this time nor did Barbian complain of any other injuries. The doctor was starting to prepare Barbian for stitches so I was only able to obtain an overview shot of Barbian's injuries.

FOLLOW UP

After I was finished at Aurora West Allis Medical Center I made contact with the owner of O'Connors Perfect Pint. Upon arrival, contact was made with Michael C. O'Connor who stated he was the owner of the tavern. O'Connor saw 'Jeff Blawat' enter the tavern with his dog. O'Conner knows Blawat due to the fact he comes in the tavern once per month or so and lives nearby. O'Conner stated a few minutes later he heard a commotion and was told Barbian had been bitten. O'Connor saw Blawat leave right afterwards with his dog and he did not return. O'Connor did not call for the police to respond after this incident.

A locals search revealed Jeffery J. Blawat resides at 1640 S. 85 St.
