The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of September.

Incident reports:

Case #13-7827, 08/30/2013, at 0122 hrs. – 6827 W. National Av. GR's National Pub.

On 08/30/2013, at 0122 hrs., Officers responded to 6827 W. National Av., GR's National Pub, regarding a patron trying to fight everyone inside the tavern and refusing to leave. Investigation revealed Aaron M. Jonasen kissed a female inside the tavern and was asked to leave. When he refused to leave, he threatened to fight everyone inside the tavern. Jonasen was arrested for disorderly conduct. He was booked, issued a municipal citation and released. The bartender, Sarah M. Reeves, told Jonasen on numerous occasions that he needed to leave the tavern. Jonasen refused to leave and Reeves called 911 to prevent any further problems. Reeves stated Jonasen was highly intoxicated, but eventually he left the tavern prior to officer arrival. Reeves provided the Officer with her bartender's license, #14-264, which was valid. She also provided the Officer with the tavern license Certificate #13-001613.

Case # 13-008328, 09/13/2013, at 2358 hrs – 7211 W. Greenfield Av., 88 Keys

On 09/13/2013, at 2358 hrs, Officers responded to 7211 W. Greenfield Av, 88 Keys, for parties fighting inside. Investigation revealed the intoxicated Mark S. Zyla, and several other intoxicated patrons, were actually splash fighting with the water table inside the tavern. After initially refusing to leave the tavern, Mark finally did. On his way out, began yelling, swearing, giving people the middle finger and threatening the bar employees. Mark was taken into custody, booked, cited and conveyed to CJF on a Probation and Parole Order to Detain.

Case #13-8371, 09/15/2013, at 2146 hrs., 1100 S. 60 St, Double Barrel Tavern

On 09/15/2013, Officers responded to 1100 S. 60 St, Double Barrel Tavern, for two females yelling at children. Officers arrived and located Rachel L. Alvey in the passenger seat of a white in color Oldsmobile with her son, Joseph Alvey, seated in the driver seat of the vehicle in the Westbound driving lane on W. Washington Ave at S. 60 St. Rachel Alvey was intoxicated and stated her son was 16 years old and valid to drive the vehicle. Investigation revealed the son is 14 years old. Rachel Alvey was arrested for Obstructing and Contributing to the Delinquency of a Minor. She was issued municipal citations and signed PR bonds. The 14 year old son stated Rachel was having problems with his father, so she went to the tavern to drink. Joseph was standing outside the tavern for an extended period of time trying to get his mother to leave, but she refused to do so.

Rachel started fighting with the bartender, lost her purse and was walking around with no shoes on. Rachel eventually left the bar, but she was too intoxicated to drive home. Officers concurred she was too intoxicated and had the vehicle towed by N&S Towing for safe keeping.

Case # 13-008585, 09/21/2013, at 2339 hrs – 6235 W. National Av., McGuire's Bar

On 09/21/2013 at 2339 hrs., Officers responded to 6235 W. National Av, McGuire's Bar for a report of an individual causing a disturbance who would not leave the bar. Officers spoke with owner, Daniel McGuire, who advised a patron, Edward C. Kleinwaechtem, was being disorderly, threatening to fight Daniel and would not leave. Edward was arrested and issued a Municipal Citation for Disorderly Conduct. Daniel further explained Edward had been in the bar earlier in the day at approximately 1500 hrs, but was asked to leave due to his intoxicated behavior. Edward had very little to drink at the bar, but had prescription medications with him. Edward left the bar and didn't cause any major problems. However, Edward returned to the bar at 2315 hrs and walked in with an alcoholic beverage in his hand. McGuire immediately told Edward he was not welcome and asked him to leave. When Edward refused, Daniel called the police.

Case #13-8598, 09/22/2013, at 0823 hrs., 7731 W. Becher St, Quenchers

On 09/22/2013, at 0823 hrs., Officers responded to 7731 W. Becher St, Quenchers for a subject being loud and refusing to leave the bar. Officers made contact with Edward Kleinwaechter who stated he was owed money from the bartender. Investigation revealed he did not pay his bar tab and the bartender, Phyllis Bourgeys, wanted him to leave. Kleinwaechter refused to leave and became loud and verbally abusive to officers. He was arrested and given a Municipal Citation for Disorderly Conduct.

Tobacco and Alcohol Compliance checks:

A Tobacco Compliance check was conducted on 09/09/2013, using a 17 year old female. The officer randomly selected 20 West Allis businesses for the compliance check. Nineteen of the businesses did not sell tobacco to the underage person. The clerk at Speedway, 715 S. 108 St, who was identified as Joseph K. Berry, sold a pack of cigarettes to the underage person. Berry

was issued a Municipal citation on scene, and the license holder for the business, identified as Daniel B. Polzin, was mailed a Municipal Citation for the same offense.

Violation of Wisconsin Clean Air Act Smoking Ban:
