Dear Council Members:

The enclosed claim has been referred to this office in accordance with Section 3.05 (6)(a) of the Revised Municipal Code. This office has examined the facts of the claim and the applicable law. Our Opinion regarding liability is as follows:

It is the recommendation of this office that the following claim be denied:

John J. Mulhaney - Amount: \$343.22

This is a claim for property damage to the claimant's vehicle on July 22<sup>nd</sup>, 2008, when the claimant allegedly ran over a pothole in the street at or near the 1500 Block of South 80<sup>th</sup> Street, West Allis, WI. As a result of the accident, the claimant needed a front-end alignment, as well as, replacement of other minor parts having to do with the front end of his vehicle. On or about August 5<sup>th</sup>, 2008, the claimant filed a claim against the City for repair of his vehicle in the total amount of \$343.22.

The investigation of this claim by the Department of Public Works indicated that no potholes could be found in the area referenced by the claimant in his claim. Even if a pothole was located, the City is only responsible for defects in streets if the City was aware of the defect prior to the incident and took no action to repair the same. Obviously, this is not the case with this claim and therefore, this matter should be handled by the claimant's automobile liability insurance carrier.

Based upon the above, it is the recommendation of the City Attorney's Office to deny this claim pursuant to the provisions of Wisconsin Municipal Claims Statute 893.80.





Thank you for your assistance and cooperation.


