

WHEREAS, the City of West Allis is considering discontinuing and vacating a 386' long x 18' wide portion of the City Right-of-Way along the South side of West National Avenue between South 78th Street and South 80th Street.

NOW, THEREFORE, BE IT RESOLVED that the Notice of Hearing, a copy of which is attached hereto, for the discontinuance and vacation of a 386' long x 18' wide Portion of the City Right-of-Way along the South side of West National Avenue between South 78th Street and South 80th Street, be published in the official City newspaper, NOW, on July 12th, 2007, July 19th, 2007 and July 26th, 2007; that the Hearing be scheduled before the Common Council on August 7th, 2007, at 7:30 p.m., or as soon thereafter as the matter may be heard; that a copy of the aforesaid Notice be served or mailed more than thirty (30) days prior to the Hearing in the manner prescribed by the law on the owners of all of the frontage of the lots and lands abutting upon the said street right-of-way proposed to be discontinued.

## NOTICE OF HEARING

The Common Council of the City of West Allis will hold a Public Hearing on August 7th, 2007, at 7:00 p.m., or as soon thereafter as the matter may be heard, in the Common Council Chambers of the City Hall, 7525 West Greenfield Avenue, West Allis, Wisconsin, upon the Resolution herein described and will act upon said Resolution at said time and place. Said Resolution was introduced into the Common Council of the City of West Allis on June 19th, 2007, and proposes the discontinuance and vacation of a 386' long x 18' wide portion of the City Right-of-Way along the South side of West National Avenue between South 78<sup>th</sup> Street and South 80<sup>th</sup> Street, legally described as follows:

A portion of the City Right-of-Way adjacent to Parcels 1, 2 and 3 of the Certified Survey Map No. 2389, located in the Northeast 1/4 of Section 4. Township 6 North, Range 21 East, in the City of West Allis, Milwaukee County, State of Wisconsin, more particularly described as follows:

Beginning at the Northwest corner of said Parcel 1; thence North 00°00'29" West, 15.41 feet; thence North 76°42'00" East, 389.58 feet; thence South 01°35'00" West, 15.52 feet to the Northeast corner of Parcel 3; thence South 76°42'00" West, 389.13 feet to the Point of Beginning.

Said land contains 5840.11 square feet, more or less.
