**RESOLUTION APPOINTING LOIS POCIAN AS PRESERVATION AGENT FOR
HONEY CREEK CEMETERY**

WHEREAS, Wis. Stat. 157.70(6m)(b)3. says the city shall endeavor to take positive action to preserve any burial site on land it owns through appropriate land use management; and

WHEREAS, the City is the cemetery authority for the Honey Creek Cemetery; and

WHEREAS, Wis. Stat. 157.11 allows the City to take management and care of the cemetery through an agent; and

WHEREAS, Wis. Stat. 157.50(2) says the City shall by ordinance manage and operate municipal cemeteries and WAMC 3.05(1)(c) and Policy 301 charge the Public Works Committee with that management duty;

NOW THEREFORE, be it resolved by the Council of the City Of West Allis, in the State of Wisconsin, as follows:

Lois Pocian is appointed as preservation agent for the Honey Creek Cemetery to serve without compensation at the pleasure of the council.

The preservation agent is authorized to:

1. Enter the grounds at reasonable hours to perform preservation work on any graves with the permission of the deceased's next of kin
2. Enter the grounds at reasonable hours to perform preservation work on any graves for which there are no next of kin;
3. Access cemetery records from the Historical Society during its regular business hours.
