ORDINANCE O-2023-0060**

**ORDINANCE TO ADOPT PARKING RESTRICTIONS ON THE SOUTH SIDE OF W.
NATIONAL AVE. FROM S. 86TH ST. TO 80' EAST OF S. 86TH ST.**

AMENDING SECTION 10.10

WHEREAS, Wis. Stat. 349.13(1e)(a) allows the City to prohibit, limit the time of or otherwise restrict the stopping, standing or parking of vehicles beyond the prohibitions, limitations or restrictions imposed by Wis. Stat. Ch. 346;

NOW THEREFORE, the common council of the City of West Allis do ordain as follows:

The south side of West National Avenue from South 86th Street to 80' east of South 86th Street shall be "No Parking, Any Time"

SECTION 1: **AMENDMENT** "Preface" of the City Of West Allis Municipal Code is hereby *amended* as follows:

AMENDMENT

Preface

The Municipal Code of the City of West Allis, WI began in-house in 2019 with the assistance of Municipal Code Corporation. This municipal code shall be cited as West Allis Municipal Code or "WAMC" as an acronym. This municipal code maintains a structure by subject matter using a decimal numbering system identifying the chapters and sections (for example: 1.01).

- The first level in the table of contents (1.01) designates the **Chapter** level;
- The second level in the table of contents (1.01) designates the **Section** level. This level sometimes involves "**Subchapters**" (to further categorize Sections).
- The third level in the table of contents (1.011) designates the **Section** level.

These number system aids in searching and referencing the WAMC and assists in subsequent codification as new ordinances are added to the WAMC. To ease internal expansion, title/chapter/section code numbers may be missing or vacant. Some may also be listed as “Reserved” for future use. To outline, give structure, and more granularly reference the legislation herein, the following list order (or pattern of ascending alphanumeric characters) is used: **1, a, i, (1), (A)** Drafting legislation with this list order better reconciles the content in local software and hard copies, with the content in this online code. The legislative history beneath a legislation’s content identifies the specific legal sources and may be provided to substantiate the online code. The WAMC is supplemented from time to time with amendments and additions made by the City of West Allis. Municipal Code Corporation provides a searchable database of the WAMC for easy reference and convenience. NOTICE: THE WAMC MAY NOT REFLECT ALL OR THE MOST CURRENT VERSION OF LEGISLATION ADOPTED BY THE WEST ALLIS COMMON COUNCIL THAT HAS YET TO BE UPDATED ONLINE. IN THE EVENT OF CONFLICT BETWEEN THE MUNICIPAL CODE AND A WRITTEN ORDINANCE, THE ORDINANCE TYPICALLY GOVERNS. SECTION 2: EFFECTIVE DATE This Ordinance shall be in full force and effect on and after the required approval and publication according to law.

SECTION 3: AUTHORIZATION The director of public works is authorized to install official traffic signs, pavement markings, or parking meters indicating any particular prohibition, limitation, or restriction.


